Objectives and Investment Policy

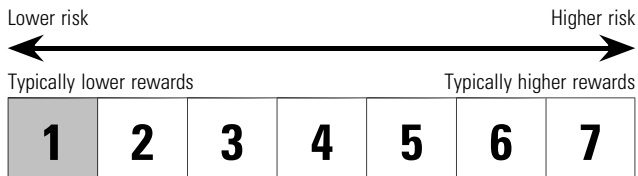
The Fund belongs to the category of fund of funds. It seeks to maintain the value of its assets by investing in other funds managed by BNP Paribas Asset Management, which belong to the category of money market funds and which invest in money market instruments denominated in EUR. The Fund may invest all its assets in the same

underlying fund. The Fund and the underlying fund(s) are actively managed against the Cash Index EONIA (RI).

Income are systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days).

Risk and Reward Profile

Money market instruments and short term bonds have a very low volatility.

- **Credit Risk:** This risk relates to the ability of an issuer to honour its commitments: downgrades of an issue or issuer rating may lead to a drop in the value of bonds in which the subfund has invested.
- **Liquidity Risk:** This risk arises from the difficulty of selling an asset at a fair market price and at a desired time due to lack of buyers.

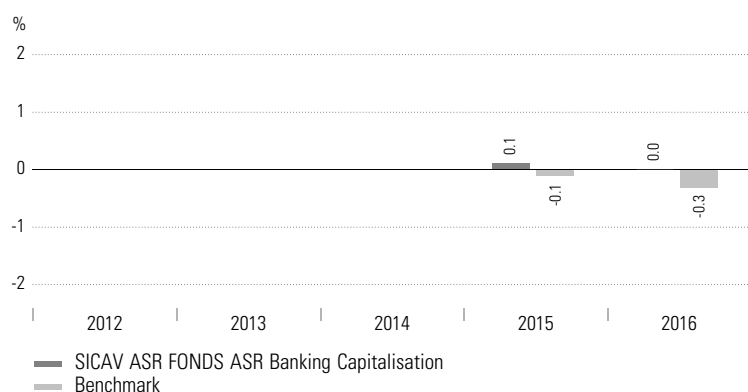
The **ongoing charges** figure is based on past expenses determined as of December 2016.
