Objectives and Investment Policy

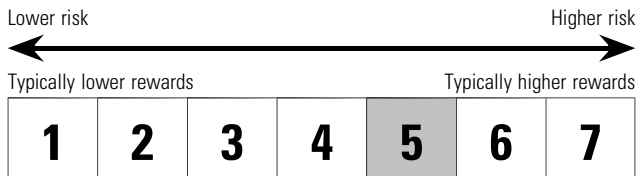
The Fund belongs to the category of fund of funds. The Fund seeks to increase the value of its assets over the medium term by investing in other funds managed by BNP Paribas Asset Management, which invest in shares issued by Dutch companies. The Fund may invest all its assets in the same underlying fund. The Fund and the underlying fund(s) are

actively managed and as such may invest in securities that are not included in the index, which is 80% AEX (RI) + 20% AEX (PI).

Income are systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days).

Risk and Reward Profile

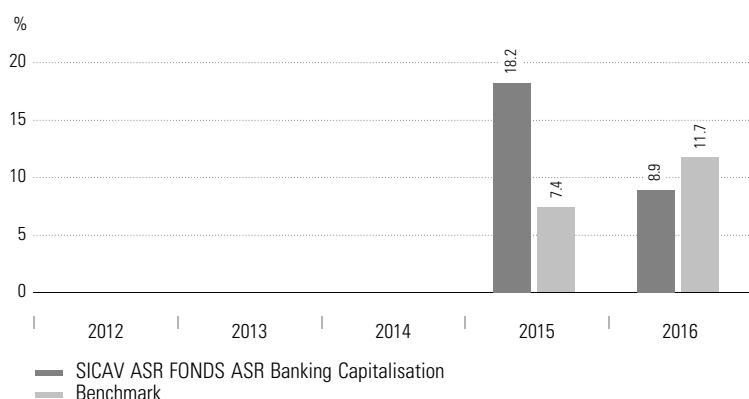
The **ongoing charges** figure is based on past expenses determined as of December 2016.
