#### Objectives and Investment Policy

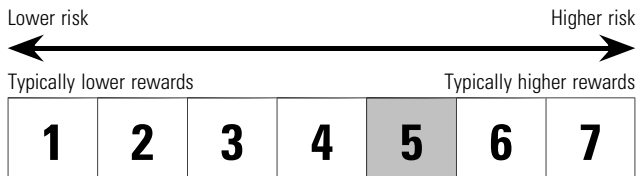
The Fund belongs to the category of fund of funds. The Fund seeks to increase the value of its assets over the medium term by investing in other funds managed by BNP Paribas Asset Management, which invest in shares issued by companies from the Pacific region or Japan. The Fund and the underlying fund(s) are actively managed and as such may

invest in securities that are not included in the index, which is 70% MSCI AC Asia Pacific ex-Japan + 30% Topix RI.

Income are systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days).

#### Risk and Reward Profile

- Why is the Fund in this specific category?

Investments in equity include significant fluctuations in prices, due for instance on negative information about the issuer or market. Moreover, these fluctuations are often amplified in the short term.

- The higher the risk, the longer the recommended investment horizon.

**Other risks materially relevant to the Fund which are not adequately captured by the indicator are described below:**

- **Liquidity Risk:** This risk arises from the difficulty of selling an asset at a fair market price and at a desired time due to lack of buyers.
- **Counterparty Risk:** This risk is associated with the ability of a counterparty in a financial transaction to fulfil its commitments like payment, delivery and reimbursement.
- **Operational and Custody Risk:** Some markets are less regulated than most of the international markets; hence, the services related to custody and liquidation for the subfund on such markets could be more risky.
- **Derivatives Risk:** When investing in over the counter or listed derivatives, the Fund aims to hedge and/or to leverage the yield of its position. The attention of the investor is drawn to the fact that leverage increases the volatility of the subfund.

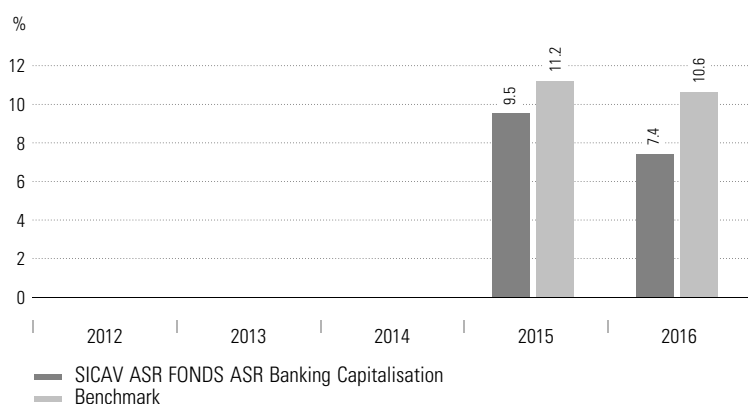
