Purpose

What is this product?

Type:

This product is a UCITS Fund.

Objectives:

The Fund aims to achieve a target average return of 3-5% over the MSCI All-Country World Index (ACWI) (Total Return, net of tax, USD) (Benchmark) before fees over the market cycle (typically 3 yrs) from investing primarily in a portfolio of global equity holdings, focusing on companies that are involved or derive benefit from the development and enhancement of mobile and 5G connectivity that meet the Sustainable Criteria, as detailed in the "Sustainable Investment Criteria" section of the Prospectus. There can be no guarantee that the Fund will ultimately achieve its investment objective. The Fund invests in equity securities that are listed or traded on recognised markets (defined in the prospectus) globally (which may include emerging (less developed) market countries). The Fund may invest in companies of any market capitalisation but shall typically invest in companies that have market capitalisation greater than USD 500 million at the time of purchase.

The Fund may invest in up to 30% of the Fund's NAV in China A-shares listed on or dealt in the Shanghai or the Shenzhen Stock Exchanges (SSEs);

China A-shares: Shares in mainland China-based companies that trade on Chinese stock exchanges such as the SSEs. A-shares are generally available for purchase by mainland citizens in China; foreign investment in A-shares is subject to significant regulatory restrictions.


The Fund is actively managed and it is not constrained by the Benchmark, which is used for performance comparison purposes only.

The Fund promotes environmental and social characteristics pursuant to Article 8 of the SFDR.

As your shares are in Singapore Dollars and the Fund is in US Dollars, currency exchange contracts are used to reduce the effect of changes in the currency exchange rate.

Income will be rolled up into the value of your investment.

What are the risks and what could I get in return? Risk Indicator

Term:

The Fund has no fixed maturity date, however it may be terminated in certain circumstances as described in the prospectus including if the Net Asset Value of the Fund does not exceed or falls below U\$\$75,000,000 (or such other amount as may be approved by the Directors).

The shares may be exchanged for shares in another sub-fund in accordance with the terms of the Prospectus. Charges may apply.

Shares in the Fund can be bought or sold on any day defined as a Business Day in Prospectus.

NBIF is established as umbrella fund with segregated liability between subfunds under Irish law.

Brown Brothers Harriman Trustee Services (Ireland) Limited (BBH) is appointed as the depositary of NBIF.

Intended retail investor:

This fund may be compatible with the needs of investors seeking a fund to deliver capital growth with an investment horizon of 5 years or more, as part of a diversified portfolio of investments. This is a medium to high risk product and investors should consider this when deciding the mix of portfolio investments. Investors who are unsure that they have the knowledge and experience to make informed investment decisions about this product or to construct a diversified portfolio should seek professional investment advice. The product is unlikely to be compatible with the needs of those investors seeking a single investment, or who require preservation of capital or to achieve a specified return by a particular date.

We have classified this product as 5 out of 7, which is a medium-high risk class. This rates the potential losses from future performance at a medium-high level, and poor market conditions will likely impact the ability for you to receive a positive return on your investment.

This product also carries market risk, operational risk, counterparty risk, currency risk, and other risks. Please refer to the "Risk Factor" section of the Prospectus. This product does not include any protection from future market performance so you could lose some or all of your investment.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.
