

# Key Investor Information

This document provides you with key investor information about this fund. It is not marketing material. The information is required by law to help you understand the nature and the risks of investing in this fund. You are advised to read it so you can make an informed decision about whether to invest.

## **Bantleon Opportunities L, a sub-fund of BANTLEON OPPORTUNITIES, class PA (ISIN: LU0337414485), EUR**

This fund is managed by the BANTLEON AG (the »Management Company«), which belongs to the BANTLEON BANK Gruppe.

### Objectives and investment policy

**Bantleon Opportunities L** is an absolute-return fund that focuses on high-quality bonds. The investment objective is to generate high returns on a regular basis by consistently adapting bond maturities and equity exposure to projected economic developments while largely avoiding debtor and exchange rate risks. The total return is comprised of the following components:

- Management of average bond maturities ranging from 0 to 9 years
- Management of equity exposure ranging from 0% to 40% of the fund's total assets
- Management of the yield curve
- Management of the bond allocation based on a good to very good credit rating
- Inclusion of inflation-indexed bonds on an intermittent basis

The investment manager invests in particular in government bonds, bonds issued by public authorities or similar safe bonds from the eurozone. Additionally, up to 50% of the fund assets may be invested in government bonds from the United States, the United Kingdom, Canada or Australia. Up to 40% of the fund assets may be invested in the global equity markets via equity index futures. The main focus is on adjusting weightings and not on selecting individual equities, so that the equity investments always fully correspond to the underlying equity markets.

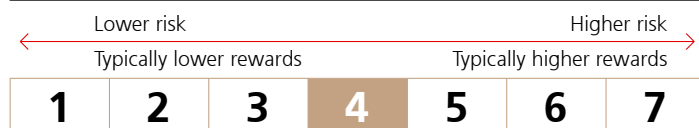
These investments may entail currency risks in USD, JPY, GBP, AUD, CAD and HKD, which are largely hedged. Unhedged foreign currency positions may make up no more than 10% of the fund assets.

Derivatives transactions may be made to hedge investments, to manage portfolio maturities, to achieve additional returns, to efficiently implement the equity allocation and to hedge against currency risks.

Investors may demand to redeem their units every normal bank business day in Luxembourg.

The fund's earnings are distributed annually at the end of the fund's year.

### Risk and reward profile



#### More about this rating

- The rating is based on price volatility over the last five years.

#### Why is this fund in Category 4?

The fund holds bonds issued by governments and quasi-governmental institutions, as well as Pfandbriefe. The fund also invests in equities to a limited extent. As the fund invests in a variety of maturities and equities, it is subject to moderate volatility.

#### Further material risks:

- Credit risks: The nature of its investment universe means that the fund is exposed to low default risk.
- Risks from the use of derivatives: The fund may use futures contracts for purposes consistent with its declared investment policy. This increases the opportunities while also increasing the risk of loss.
- Operational risks: The fund is subject to risks through operational or human error. The management company is monitored by independent internal and external auditors, as well as by the regulators.

## Charges

The charges you pay are used to pay the costs of running the sub-fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

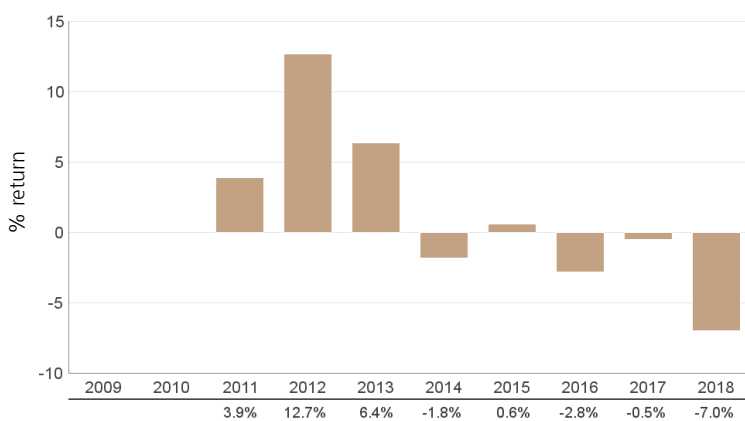
The **entry charge** and **exit charge** shown are the maximum figures. In some cases you might pay less – the actual figure can be found out from your financial adviser.
