Entsprechend dem uns von der ordentlichen Generalversammlung der Aktionäre erteilten Auftrag vom 30.04.2014 haben wir den beigefügten Jahresabschluss der responsAbility SICAV (Lux) und ihrer jeweiligen Teilfonds geprüft, der aus der Aufstellung des Nettofondsvermögens, des Wertpapierbestands und der sonstigen Nettovermögenswerte zum 31.12.2014, der Ertrags- und Aufwandsrechnung und der Entwicklung Nettofondsvermögens für das an diesem Datum endende Geschäftsjahr sowie aus einer Zusammenfassung bedeutsamer Rechnungslegungsmethoden und anderen erläuternden Informationen besteht.

Verantwortung des Verwaltungsrats der SICAV für den Jahresabschluss

Der Verwaltungsrat der SICAV ist verantwortlich für die Aufstellung und sachgerechte Gesamtdarstellung des Jahresabschlusses in Übereinstimmung mit den in Luxemburg geltenden gesetzlichen Bestimmungen und Verordnungen zur Aufstellung des Jahresabschlusses und für die internen Kontrollen, die er als notwendig erachtet, um die Aufstellung des Jahresabschlusses zu ermöglichen, der frei von wesentlichen unzutreffenden Angaben ist, unabhängig davon, ob diese aus Unrichtigkeiten oder Verstößen resultieren.

Verantwortung des Réviseur d'Entreprises agréé

In unserer Verantwortung liegt es, auf der Grundlage unserer Abschlussprüfung über diesen Jahresabschluss ein Prüfungsurteil zu erteilen. Wir führen unsere Abschlussprüfung nach den für Luxemburg von der Commission de Surveillance du Secteur Financier angenommenen internationalen Prüfungsstandards (*International Standards on Auditing*) durch. Diese Standards verlangen, dass wir die beruflichen Verhaltensanforderungen einhalten und die Prüfung dahingehend planen und durchführen, dass mit hinreichender Sicherheit erkannt werden kann, ob der Jahresabschluss frei von wesentlichen unzutreffenden Angaben ist.

Eine Abschlussprüfung beinhaltet die Durchführung von Prüfungshandlungen zum Erhalt von Prüfungsnachweisen für die im Jahresabschluss enthaltenen Wertansätze und Informationen. Die Auswahl der Prüfungshandlungen obliegt der Beurteilung des Réviseur d'Entreprises agréé ebenso wie die Bewertung des Risikos, dass der Jahresabschluss wesentliche unzutreffende Angaben aufgrund von Unrichtigkeiten oder Verstößen enthält. Im Rahmen dieser Risikoeinschätzung berücksichtigt der Réviseur d'Entreprises agréé das für die Aufstellung und sachgerechte Gesamtdarstellung des Jahresabschlusses eingerichtete interne Kontrollsysteem, um die unter diesen Umständen angemessenen Prüfungshandlungen festzulegen, nicht jedoch, um eine Beurteilung der Wirksamkeit des internen Kontrollsysteins abzugeben.

Eine Abschlussprüfung umfasst auch die Beurteilung der Angemessenheit der angewandten Rechnungslegungsgrundsätze und -methoden und der Vertretbarkeit der vom Verwaltungsrat der SICAV ermittelten geschätzten Werte in der Rechnungslegung sowie die Beurteilung der Gesamtdarstellung des Jahresabschlusses.

Wir sind der Auffassung, dass die von uns erlangten Prüfungsnachweise ausreichend und geeignet sind, um als Grundlage für unser Prüfungsurteil zu dienen.

Prüfungsurteil

Nach unserer Beurteilung vermittelt der Jahresabschluss in Übereinstimmung mit den in Luxemburg geltenden gesetzlichen Bestimmungen und Verordnungen betreffend die Aufstellung des Jahresabschlusses ein den tatsächlichen Verhältnissen entsprechendes Bild der Vermögens- und Finanzlage der responsAbility SICAV zum 31.12.2014 sowie der Ertragslage und der Entwicklung des Nettofondsvermögens für das an diesem Datum endende Geschäftsjahr.

Sonstiges

Die im Jahresbericht enthaltenen ergänzenden Angaben wurden von uns im Rahmen unseres Auftrages durchgesehen, waren aber nicht Gegenstand besonderer Prüfungshandlungen nach den oben beschriebenen Standards. Unser Prüfungsurteil bezieht sich daher nicht auf diese Angaben. Im Rahmen der Gesamtdarstellung des Jahresabschlusses haben uns diese Angaben keinen Anlass zu Anmerkungen gegeben.

Following our appointment by the general meeting of the Shareholders of 30.04.2014, we have audited the accompanying financial statements of responsAbility SICAV (Lux) and each of its sub-funds, which comprise the statement of net assets and the statement of investments and other net assets as at 31.12.2014 and the statement of operations and the statement of changes in net assets for the year then ended, and a summary of significant accounting policies and other explanatory information.

Board of Directors of the SICAV's responsibility for the financial statements

The Board of Directors of the SICAV is responsible for the preparation and fair presentation of these financial statements in accordance with Luxembourg legal and regulatory requirements relating to the preparation of the financial statements, and for such internal control as the Board of Directors of the SICAV determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

Responsibility of the Réviseur d'Entreprises agréé

Our responsibility is to express an opinion on these financial statements based on our audit. We conducted our audit in accordance with International Standards on Auditing as adopted for Luxembourg by the Commission de Surveillance du Secteur Financier. Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the judgment of the Réviseur d'Entreprises agréé, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the Réviseur d'Entreprises agréé considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control.

An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by the Board of Directors of the SICAV, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Opinion

In our opinion, the financial statements give a true and fair view of the financial position of responsAbility SICAV (Lux) and each of its sub-funds as of 31.12.2014, and of the results of their operations and changes in their net assets for the year then ended in accordance with Luxembourg legal and regulatory requirements relating to the preparation of the financial statements.

Other matter

Supplementary information included in the annual report has been reviewed in the context of our mandate but has not been subject to specific audit procedures carried out in accordance with the standards described above. Consequently, we express no opinion on such information. However, we have no observation to make concerning such information in the context of the financial statements taken as a whole.

responsAbility SICAV (Lux) was established on 6.11.2006 as an open-ended undertaking for collective investment in the legal form of an investment company with variable capital (société d'investissement à capital variable, SICAV) in accordance with Part II of the law of 20.12.2002 on undertakings for collective investment ("Law of 20.12.2002") in co-operation with Credit Suisse Holding Europe (Luxembourg) S.A., Luxembourg, a wholly owned subsidiary of Credit Suisse AG, Zurich, and responsAbility Investments AG, Zurich (former responsAbility Social Investments AG, Zurich). The Law of 20.12.2002 was superseded by the Law of 17.12.2010 on undertakings for collective investment ("Law of 2010").

As of 31.12.2014 the Fund had 3 subfunds.

- responsibility SICAV (Lux) Mikrofinanz-Fonds -I II- CHF: the first NAV was calculated on 31.07.2014

Summary of significant accounting policies**a) Computation of the net asset value of each subfund**

The net asset value of the Shares of each Subfund shall be calculated under the responsibility of the Board of Directors of the Company in Luxembourg on the last banking day of each month in the reference currency of the respective Subfund (each such day being referred to as a "Valuation Day"). The financial statements reflect the net asset value as calculated on 31.12.2014.

b) Valuation of investment securities of each subfund

Debt instruments, and especially promissory notes, not listed on a stock exchange or another regulated market plus claims arising from loans will be valued at their nominal value plus accrued interest. This valuation will be adapted, in the event of major fluctuations in interest rates in the relevant markets or in the event of other material market developments, if such circumstances affect the value of the investments.

In the event of default or another critical situation that could lead to default, or in the case of the elimination or improvement of such a situation, the Company shall decide on the basis of the information available to the Investment Adviser as to whether and to what extent an adjustment should be made to the valuation of debt instruments.

Securities which are listed on a stock exchange or which are regularly traded on a stock exchange shall be valued at the last known purchase price. If such a price is not available for a particular exchange session, but a closing mid-price (the mean of the listed closing bid and ask prices) or a closing bid price is available, then the closing mid-price, or alternatively the closing bid price, may be taken as a basis for the valuation.

If a security is traded on more than one stock exchange, the valuation shall be made by reference to the exchange on which it is chiefly traded.

In the case of securities for which trading on a stock exchange is not significant but which are bought and sold on a secondary market with regulated trading among securities dealers (with the effect that the price is set on a market basis), the Company may decide to base the valuation on this secondary market. Securities traded on a regulated market shall be valued in the same way as securities listed on a stock exchange.

Securities that are not listed on a stock exchange and are not traded on a regulated market shall be valued at their last available market price. If no such price is available, the Company shall value the securities in accordance with other criteria that it shall establish and on the basis of the probable sales price, which shall be estimated with due care and in good faith.

If a valuation in accordance with the above rules is rendered impossible or incorrect owing to special or changed circumstances, the Company's Board of Directors shall be entitled to use other generally recognized and auditable valuation principles in order to value the assets.

The valuation price of a money market instrument shall be progressively adjusted to the redemption price, based on the net acquisition price and keeping the resultant investment yield constant. In the event of a significant change in market conditions, the basis for the valuation of individual investments shall be brought into line with the new market yields.

Units in undertakings for collective investment will be valued at their last-stated net asset value. Other valuation methods may be used to adjust the price of these units if, in the opinion of the Company, it has changed since the net asset value was last calculated.

c) Net realised gain/loss on sales of investments of each subfund

The realised gains or losses on the sales of securities are calculated on the basis of the average acquisition cost.

d) Cash at banks and at brokers

Cash at banks and at brokers includes cash in hand, margin calls and deposits held at call with banks and other short-term investments in an active market with original maturities of three months or less and bank overdrafts.

e) Foreign exchange conversion

Cash at banks, other net assets and the value of portfolio securities in currencies other than reference currency are converted into the reference currency at the foreign exchange rate prevailing on the day before the date of valuation.

Income and expenses in currencies other than reference currency are converted into the reference currency at the foreign exchange rate applicable at the date they accrue to the subfund.

Realised gains or losses on foreign currencies are accounted for in the statement of operations.

The acquisition cost of securities in currencies other than the reference currency is converted into the reference currency at the foreign exchange rate valid at the date of acquisition.

f) Transactions on investments in securities

The transactions on investments in securities are booked on a trade date basis.

g) Valuation of forward foreign exchange contracts of each subfund

Unmatured forward foreign exchange contracts are valued at the date before the valuation date at forward exchange rates prevailing at this date and resulting unrealised gains or losses are posted to the statement of operations and are shown under other assets/liabilities in the statement of net assets.

h) Valuation of swaps

On each valuation day, swap agreements are valued at the net present value of the future cash flows, using the relevant interest rate yield curve on the date before the valuation day (for MFX Solutions T-3 is used).

Asset swaps and the securities linked to the asset swaps are not revalued as the security and the asset swap are considered for the purpose of the valuation as a single instrument.

i) Income recognition

Dividends are recorded on ex-dividend date, net of withholding tax. Interests are accrued on a daily basis.

Management fee

(see detail at subfund level)

As remuneration for its services and reimbursement of its expenses, the Management Company is entitled to a yearly management fee, payable at the end of each month and may not exceed 2.2% of the average total net assets of the Fund per year.

Charges incurred by the Company in relation to the provision of investment advice, distribution and other unspecified services rendered for the Company shall be paid out of the management fee.

Private Equity transactions in the securities portfolio

The cost of underlying investments is comprised of capital contributions which reduce the total unfunded commitment. Late entry fees are not recorded as part of the cost and are expensed immediately as they are not part of the total commitments.

Late entry fees are penalty fees to pay in case of investments in existing funds. These fees were included in the cost of the investments in the previous years and are shown separately since this year.

During the year ended 31.12.2014 only the subfund responsAbility SICAV (Lux) Microfinance Leaders had Late entry fees for USD 20.43.

"Taxe d'abonnement"

The Company's assets are exempt from the tax normally payable quarterly by undertakings for collective investment in the Grand Duchy of Luxembourg ("taxe d'abonnement") as of 14.07.2010, as the main purpose of the Company is investment in MFIs.

The TER expresses the sum of all costs and commissions charged on an ongoing basis to the fund's assets, taken retrospectively as a percentage of these assets. No TER is disclosed for units launched less than 6 months ago.

Changes in the composition of the securities portfolio

Changes in the composition of the securities portfolio during the reporting period are available to shareholders free of charge at the registered office of the Management Company or the local representatives in the countries where the Fund is registered.

Exchange Rates

The consolidated financial statements are kept in USD. For this purpose, the financial statements of the subfunds are converted into USD at the foreign exchange rate as of 31.12.2014:

1 EUR = 1.210050 USD

Other liabilities

Other liabilities include the provisions done for investments which are classified as critical (late payments, political disturbance). In the previous financial statements these provisions were directly adjusted in the valuation of the concerned investments.

For the subfund responsAbility SICAV Mikrofinanz-Fonds the provision amounts to EUR 2,062,316 and for the subfund responsAbility SICAV Microfinance Leaders the provision amounts to USD 4,959,586 and for the subfund responsAbility SICAV Financial Inclusion Fund the provision amounts to USD 407,076. They are shown in the statement of investments in securities and other net assets under risk provision on investments.

Transaction costs

Transactions costs include brokerage fees, stamp duty, local taxes and other foreign charges if incurred during the period. Transaction costs are included in the cost of securities purchased and sold.

Not all transaction costs are separately identifiable. For fixed income investments, forward currency contracts and for some other derivative contracts, transaction costs will be included in the purchase and sales price of the investment. Whilst not separately identifiable these transaction costs will be captured within the performance of each subfund.

Other liabilities

Other liabilities include the outstanding interest on swaps.

AIFM

The Company has appointed Credit Suisse Microfinance Fund Management Company as AIFM. The AIFM was incorporated in Luxembourg on November 22, 1993 as a joint-stock company for an indefinite period under the name CS Forex Fund Management Company. In addition to the provisions of the Law of July 12, 2013 it is subject to the provisions of section 16 of the Law of 2010. After several name changes the name Credit Suisse Microfinance Fund Management Company was adopted on October 15, 2003. The original articles of incorporation were published in the "Mémorial" on January 5, 1993 and are deposited at the Commercial and Company Register of Luxembourg for inspection. The articles of incorporation were last amended on July 25, 2014 and published in the "Mémorial" on August 26, 2014. The AIFM is registered at the Luxembourg Registry of Commerce under no. R.C.S. B 45 629. It has its registered office in Luxembourg at 5, rue Jean Monnet, L-2180 Luxembourg. The AIFM's equity capital amounts to CHF 300,000. The share capital is held by Credit Suisse Holding Europe (Luxembourg) S.A., Luxembourg. In order to cover possible liability risk resulting from its activity as AIFM, the AIFM has sufficient, additional capital suitable for covering the potential liability risks attributable to negligence.

Material Changes

In accordance with the Law of 12 July 2013 on alternative investment fund managers, we hereby declare that no material changes occurred during the period to report.

Remuneration

Shareholders may obtain details on the remunerations paid by the AIFM to its staff at the registered office of the Company.

responsAbility SICAV (Lux) Financial Inclusion Fund

During the review period, which lasted from January 1 to December 31, 2014, the Subfund's total assets expanded from USD 165.5 million to USD 171.3 million.

On December 31, 2014, the net asset value in US dollars was USD 1,152.24, giving an annual return of 3.55%.

With 89% of the Subfund's assets invested in fixed-income investments, cash holdings come to 11%.

In contrast to the other SICAV (Lux) subfunds of responsAbility, transactions that are not effected in the Subfund's currency are not always hedged with forward foreign exchange transactions. This can increase the volatility of returns. Value adjustments amount to CHF 0.4 million.

Investment Policy

The total investment volume in the year under review was USD 68.1 million, with 99 direct microfinance transactions taking place. Demand for financing was high throughout the review period, though with the usual seasonal fluctuations. The investment volume was easily the highest in the fourth quarter. Regional diversification was expanded to 60 countries, with Central Asia, South America and Asia-Pacific accounting for 62% of the volume.
