What is this product?

Type:

This product is a UCITS Fund.

Objectives:

The Fund aims to achieve a target average return of 1% over the Benchmark comprising of one third JPMorgan GBI Emerging Markets Global Diversified Investment Grade 15% Cap Index (Total Return, Unhedged, USD) and two thirds to JP Morgan EMBI Global Diversified Investment Grade Index (Total Return, USD) (Benchmark) before fees over a market cycle (typically 3 years) by investing primarily in a blend of investment grade rated hard currency (defined as USD, EUR, GBP, JPY, CHF) and local emerging (less developed) market currency denominated debt, issued by sovereigns, quasi-sovereigns, sub-sovereigns and corporate credits in emerging market countries that meet the Sustainable Criteria, as detailed in the "Sustainable Investment Criteria" section of the prospectus. There can be no guarantee that the Fund will ultimately achieve its investment objective. The Fund is managed with a disciplined approach which begins with analysis of the market environment then with identifying asset classes with attractive valuations and liquidity. Investment selection is the result of fundamental analysis that identifies issuers that are believed to be undervalued and have strong credit quality and comply with the Sustainable Criteria. Investments are made in investment grade securities that are highly rated, generally those rated Baa3, BBB- or above by one or more recognised rating agencies.

The Fund is actively managed and it is not constrained by the Benchmark, which is used for performance comparison purposes only.

The Fund promotes environmental and social characteristics pursuant to Article 8 of the SFDR.

As your shares are in Norwegian Kroner and the Fund is in US Dollars, currency exchange contracts are used to reduce the effect of changes in the currency exchange rate.

Income will be rolled up into the value of your investment.

Term:

The Fund has no fixed maturity date, however it may be terminated in certain circumstances as described in the prospectus including if the Net Asset Value of the Fund does not exceed or falls below US\$75,000,000 (or such other amount as may be approved by the Directors).

The shares may be exchanged for shares in another sub-fund in accordance with the terms of the Prospectus. Charges may apply.

Shares in the Fund can be bought or sold on any day defined as a Business Day in Prospectus.

NBIF is established as umbrella fund with segregated liability between sub-funds under Irish law.

Brown Brothers Harriman Trustee Services (Ireland) Limited (BBH) is appointed as the depositary of NBIF.

Intended retail investor:

This fund may be compatible with the needs of investors seeking a fund to deliver income or capital growth with an investment horizon of 3 years or more, as part of a diversified portfolio of investments. This is a medium to high risk product and investors should consider this when deciding the mix of portfolio investments. Investors who are unsure that they have the knowledge and experience to make informed investment decisions about this product or to construct a diversified portfolio should seek professional investment advice. The product is unlikely to be compatible with the needs of those investors seeking a single investment, or who require preservation of capital or to achieve a specified return by a particular date.

What are the risks and what could I get in return?

Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level and poor market conditions are very unlikely to impact the value of your investment. This product also carries market risk, operational risk, counterparty risk, currency risk, and other risks. Please refer to the "Risk Factor" section of the Prospectus. This product does not include any protection from future market performance so you could lose some or all of your investment.

What happens if NBAMIL is unable to pay out?
