Objective and Investment Policy

Investment Objective

The Sub-Fund investment objective is firstly to seek high income and secondary capital growth by investing in US high yield debt securities over a long term period.

Investment Policy

The Sub-Fund is actively managed in order to capture opportunities in US bonds offering high income and credit default swaps. The following investment decisions are undertaken after comprehensive macroeconomic and microeconomic analysis of the market:

- issuer selection
- sector allocation
- credit curve positioning (the credit curve illustrates the relationship between the investment term and the credit yield)

The Sub-Fund invests essentially in high yield fixed or floating rates bonds issued in the US domestic market by public or private companies and credit default swaps referencing such bonds. Such high return bonds have a rating lower than BBB- according to Standard & Poor's or equivalent rating (Moody's or other rating agency) or are not rated. The net market exposure of the Sub-Fund will be between 75% and 150% of its net assets.

The selection of credit instruments is not exclusively and mechanically based on their publicly available credit ratings but also on an internal credit or market risk analysis. The decision to buy or sell assets is also based on other analysis criteria of the Investment Manager.

The Sub-Fund may invest not more than one third of its total assets in Money Market Instruments, not more than one quarter of its assets in convertible securities and not more than one tenth of its assets in equity.

Within the limits above, the investment strategy may be achieved by direct investments and/or through derivatives, especially by entering into Credit Default Swaps. Derivatives may also be used for hedging purposes.

Income

For Capitalisation share classes (Cap), the dividend is reinvested.

Sub-Fund Currency

The reference currency of the Sub-Fund is USD.

Investment Horizon

This Sub-Fund may not be suitable for investors who plan to withdraw their contribution within 7 years.

Processing of subscription and redemption orders

The subscription, conversion or redemption orders must be received by the Registrar and Transfer Agent on any Valuation Day no later than 3 p.m. Luxembourg time. Orders will be processed at the Net Asset Value applicable to such Valuation Day. The investor's attention is drawn to the existence of potential additional processing time due to the possible involvement of intermediaries such as Financial Advisers or distributors.

The Net Asset Value of this Sub-Fund is calculated on a daily basis.


