Objective and Investment Policy

Investment Objective

The Sub-Fund seeks to provide long-term capital appreciation, measured in USD, by investing in global equity securities.

Investment Policy

The Sub-Fund will seek to capture the equity premium in an economical manner by investing in a diversified portfolio of equity and equity related instruments issued by all capitalization companies worldwide excluding emerging markets.

The portfolio construction will focus on systematic sources of risk and return that are commonly referred to as "Smart Beta premia" assessed through the use of a proprietary quantitative process. In addition the Sub-Fund flly integrates Environment, Social and Governance (ESG) factors according to AXA IM proprietary ESG framework and corresponding scoring for each holding.

The Sub-Fund may invest in Money Market Instruments.

The Sub-Fund will invest not more than 10% of its nets assets in units of UCITS and/or UCIs.

Within a limit of 200% of the Sub-Fund's net assets, the investment strategy may be achieved by direct investments and/or through derivatives. Derivatives may also be used for hedging purposes.

Investment Horizon

This Sub-Fund may not be suitable for investors who plan to withdraw their contribution within 8 years.


