Facilities Agent

In connection with the Company's recognition under section 264 of the Financial Services and Markets Act 2000, the Company, by way of a UK Facilities Agency Agreement effective from 13 February 2014, has appointed BNP Paribas Securities Services, London Branch (the "Facilities Agent") to maintain the facilities required of a recognised scheme pursuant to the rules contained in the Collective Investment Schemes Sourcebook ("COLL") published by the Financial Conduct Authority.

The facilities will be located at the offices of the Facilities Agent: BNP Paribas Securities Services, London Branch, Facilities Agency Services, c/o Company Secretarial Department, 10 Harewood Avenue, London, NW1 6AA, United Kingdom during usual business hours on any week day (other than UK public holidays):

At these facilities, any person may:

- 1 inspect (free of charge) a copy (in English) and to obtain (free of charge, in the case of the documents at (c) ,(d) and (e) below, and otherwise at no more than a reasonable charge) the following:
 - (a) the instrument constituting the Company;
 - (b) any instrument amending the instrument constituting the Company;
 - (c) the latest prospectus (which must include the address where the facilities are maintained and details of those facilities);
 - (d) the key investor information document;
 - (e) the latest annual and half-yearly reports; and
