Objectives and Investment Policy


The Fund belongs to the category of fund of funds. The Fund seeks to increase the value of its assets over the medium term by investing in other funds managed by BNP Paribas Asset Management, which invest in debt instruments denominated in EUR. The Fund and the underlying fund(s) are actively managed and as such may invest in securities that are not included in the index, which is 40% Barclays Euro Aggregate

Treasury AAA (RI) + 35% Barclays Euro Aggregate 500MM (RI) + 25% Barclays Euro Aggregate Corporate 500MM (RI).

Income are systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days).


