## What is this product?

### TYPE OF PRODUCT

The product is a Sub-Fund of Weissshorn Funds UCITS, an Undertaking for Collective Investment in Transferable Securities (UCITS) incorporated as a variable capital investment company (SICAV) under the laws of Luxembourg.

### TERM

The Sub-Fund is established for an unlimited duration. However, the board of directors may also propose to dissolve a sub-fund at a General Meeting of that Compartment.

### OBJECTIVES

#### Objectives and investment policy

The Investment Objective of Europa Acciones is to offer to its Shareholders the possibility to invest in a diversified portfolio of equities.

The investment objective of the Sub-Fund is to seek long-term capital growth and income by investing in equities, fixed/floating income instruments, money market instruments, cash equivalents, collective investment schemes pursuing traditional strategies and to a lesser extent alternative strategies UCITS eligible funds.

In order to reach its objective, the Sub-Fund will mainly invest directly or through funds in equity and equity related securities (preferred shares – as defined in the prospectus-, ADR (American Depositary Receipt), GDR (Global Depositary Receipt), ...), in debt instruments (government bonds, short/long maturity bonds, fixed/variable rate securities, senior/subordinated debt, inflation-linked securities, investment grade/high yield bonds, convertible or reverse convertible bonds, financial/corporate debt), money market instruments and cash equivalents.

The choice of investments will neither be limited by geographical area (including emerging markets), an economic sector, nor in a particular asset class, nor in currencies in which investments will be denominated. However, depending on financial market conditions, a particular focus can be placed in a single country and/or in a single economic sector and/or single asset class and/or in a single currency.

On an ancillary basis, the Sub-Fund may invest in other eligible assets, undertakings for collective investment (UCIs) and cash. To a lesser extent, the Sub-Fund may invest in structured products or UCITS eligible funds with alternative strategies as further described in the prospectus.

All investments will be made in accordance with the provision set out under article 41 of the Law of 2010.

However, the Sub-Fund may invest directly in the assets listed below, subject to the following limits:

- Debt securities or issuers may have credit rating of all types (see details in prospectus)
- The investment manager does not intend to invest in contingent convertible bonds.
- Total investments in funds will represent less than 50% of the net assets.
- Total equity exposure coming from direct investments or from UCIs with as main investment objective in their issue document to invest in equity will not exceed 50% of the net assets.

If the investment manager considers this to be in the best interest of the shareholders, on a temporary basis and for defensive purposes, the Sub-Fund may also hold, up to 100% of its net assets, liquidities, such as cash deposits, money market UCIs and money market instruments, treasury bills and other short-term sovereign securities.

**Derivatives** For hedging and for any other purposes, the Sub-Fund may use financial derivative instruments within the limits and descriptions set out in the prospectus. The use of derivative instrument may increase leverage, imply additional costs and risks.

**Benchmark** The Sub-Fund is actively managed. The Sub-Fund has no benchmark index and is not managed in reference to a benchmark index.

**Dividend Policy** This Class is cumulative. Dividend distributions are not planned.

**Share Class Currency** The currency of the Class is EUR.

The recommended holding period of this product is determined to allow sufficient time for this product to reach its objectives and avoiding short term market fluctuations.

The return of the product is determined using the Net Asset Value (the "NAV") calculated by the Central administration. This return depends mainly on the market value fluctuations of the underlying investments.

### INTENDED RETAIL INVESTORS

The product is suitable for retail investors with limited knowledge of the underlying financial instruments and no financial industry experience. The product is compatible with investors who may bear capital losses and who do not need capital guarantee. The product is compatible with clients looking for growing their capital and who wish to hold their investment over 5 years.

**Depositary** Pictet & Cie (Europe) S.A. (the "Depositary").

**Asset segregation** The assets and liabilities of each sub-fund are segregated by law, which means that the performance of the assets in other sub-funds does not influence the performance of your investment.

**Dealing** The net asset value for the Class is calculated on each bank business day in Luxembourg ("Calculation Day") on the basis of the prices of the preceding business day ("Valuation Day"). The cut-off time to submit subscriptions and /or redemption orders is 12 noon at the latest one business day before the relevant Valuation Day.

**Switching** Shareholders may apply for any shares of any sub-funds to be converted into shares of another sub-fund, provided that the conditions for accessing the target share class, type or sub-type, are fulfilled with respect to this Sub-Fund, on the basis of their respective net asset value calculated on the valuation day following receipt of the conversion request. The redemption and subscription costs connected with the conversion may be charged to the shareholder as indicated in the prospectus. ## What happens if FundPartner Solutions (Europe) S.A. is unable to pay out?

The Management Company is not making any payment to you in relation to this Sub-Fund and you would still be paid in case of a default from the Management Company.

The Sub-Fund's assets are held with a separate company, the Depositary, so the Sub-Fund's ability to pay out would not be affected by the insolvency of the Management Company. However, in the event of the Depositary's insolvency, or its delegates, the Sub-Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Sub-Fund. The Depositary will also be liable to the Sub-Fund or its investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfill its obligations (subject to certain limitations).

If the Sub-Fund is terminated or wound up, the assets will be liquidated and you will receive an appropriate share of any proceeds but you may lose part or all of your investment.

There is no compensation or guarantee scheme protecting you from a default of the Depositary.

## What are the costs?

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. - In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
