General information on the Company

TCW Funds (the "Fund") is a *société d'investissement à capital variable* (SICAV) incorporated on December 7, 2011 under Luxembourg Law and listed on the official list of undertakings for collective investment authorised under Part I of the amended Law of December 17, 2010 ("the 2010 Law") relating to undertakings for collective investment in transferable securities (UCITS) which implemented into Luxembourg law the Directive 2009/65/EC of the European Parliament and of the Council of July 13, 2009 on the coordination of laws, regulations and administrative provisions relating to UCITS and the implementation measures of the Directive 2009/65/EC.

CARNE Group has been appointed as Management Company of the Fund from September 15, 2017, and that previously the Fund was qualified as a self-managed SICAV.

The deed of incorporation of the Fund, including the Articles of Incorporation, were published in the *Mémorial C, Recueil des Sociétés et Associations*, number 3212 on December 30, 2011. The Articles of Incorporation were amended on May 22, 2012. The coordinated Articles of Incorporation were published in the *Mémorial* number 1398 on June 6, 2012.

The capital of the Fund is expressed in USD, represented by Shares with no mention of nominal value, paid in full at the time of their issue. The capital is at all times equal to the total of the Net Assets of all the Sub-Funds.

The Articles of Incorporation have been deposited and are available for inspection at the Luxembourg Trade Register (*Registre de commerce et des sociétés de Luxembourg*). The Fund is registered with the Luxembourg Trade Register under number B 165.275.

The Fund is an "**umbrella fund**" within the meaning of article 181 of the 2010 Law and is divided into multiple Sub-Funds each representing a separate portfolio of assets and series of shares. Any particular Sub-Fund can be further divided into different Classes to accommodate different subscription and redemption provisions and/or fees and charges to which they are subject, as well as their availability to certain types of investors. All references to a Sub-Fund, shall, where the context requires, include any Class of Shares that belongs to such Sub-Fund.

The Fund may create further Sub-Funds, thereby issuing new Classes. When such new Sub-Funds are created, the Prospectus will be amended accordingly, in order to provide all the necessary information on such new Sub-Funds. A Key Investor Information Document relating to each new Sub-Fund's Class of Shares will also be issued accordingly.

Each Sub-Fund corresponds to a separate portfolio of assets. Each such portfolio of assets is allocated only to the Shares in issue and outstanding within each Sub-Fund. Each Sub-Fund and Class, if any, will bear its own liabilities.

Information to the Shareholders

The annual general meeting of shareholders is held, in accordance with Luxembourg law, in Luxembourg at the registered office of the Fund or such other place in the municipality of the registered office as may be specified in the notice of the meeting on the last Tuesday of January at 2 p.m. CET.

If such day is not a bank business day in Luxembourg, then the annual general meeting shall be held on the first succeeding bank business day in Luxembourg. The annual general meeting may be held abroad if, in the absolute and final judgment of the Board of Directors, exceptional circumstances so require.

Other meetings of shareholders may be held at such place and time as may be specified in the respective notices of meeting.

The shareholders of any Sub-Fund may hold, at any time, general meetings to decide on any matters which relate exclusively to such Sub-Fund. In addition, the shareholders of any class of shares may hold, at any time, general meetings to decide on any matters which relate exclusively to such class of shares. The general provisions set out in these Articles of Incorporation, as well as in the 1915 Law (the Luxembourg law of August 10, 1915 on commercial companies, as amended from time to time), shall apply to such meetings.

All the Investors shall be convened to the meeting via a notice, recorded in the register of Investors and sent to their addresses in accordance with Luxembourg law. This notice shall indicate the time and place of the annual general meeting of shareholders, the admission conditions, the agenda and the quorum and majority requirements.

The Board of Directors is not required to send the annual accounts, as well as the report of the auditors of the Fund and the management report at the same time as the convening notice to the annual general meeting of shareholders. Unless otherwise provided for in the convening notice to the annual general meeting of shareholders, the annual accounts, as well as the report of the auditors of the Fund and the management report, will be available at the registered office of the Fund. The convening notice to general meetings of shareholders may provide that the quorum and the majority at the general meeting is determined according to the shares issued and outstanding at midnight (Luxembourg time) on the fifth day prior to the general meeting (referred to as "record date"). The right of an Investor to attend a general meeting and to exercise a voting right attaching to his shares is determined in accordance with the shares held by the Investor at the record date.

Each Share grants the right to one vote. The vote on a possible payment of a dividend in a Sub-Fund requires the majority of the votes of the Investors of the concerned Sub-Fund and any amendment to the Articles of Incorporation leading to a change in the Investor rights of a Sub-Fund must be approved by a decision of the General Meeting of shareholders and by the Meeting of the concerned Sub-Fund's Investors.

Report of the Board of Directors of the Fund

To Our Valued Shareholders:

We submit the 2017 annual report for the TCW Funds. This report contains information outlining the performance and a list of the portfolio holdings as of 30 September, 2017.

Geopolitical and idiosyncratic risks have been simultaneously heightened and severely discounted by investors during this period. Notwithstanding brief bouts of market volatility resulting from heated rhetoric between the U.S. and North Korea toward the latter part of the year, devastating natural disasters in the southeast, and contentious political discourse, the overarching theme was one of upward-trending markets propagated by still-accommodative central banks. Meanwhile, market volatility measures such as the VIX hovered near historical lows, illustrative of the apparent complacency supporting price levels even as the number of potential catalysts to overturn frothy valuations grew. While late 2016/early 2017 sentiment held that the new administration in Washington DC was poised to spur a faster pace of economic growth with passage of long-absent fiscal stimulus, political reality (and intransigence) has frustrated much in the way of legislative progress. As a result, no meaningful acceleration in GDP has occurred, wage growth remains limited despite job gains, and a lack of inflationary pressure persists, the combination of which reveals little fundamental support for the lack of risk aversion in evidence. Though corporate earnings have been resilient and modestly growing, indications are that profit momentum has been sustained more by financial engineering than robust top-line growth.

Despite a lack of fundamental catalysts for the recent return environment, the market for risk assets remained buoyant, with the S&P 500 Index touching multi-record highs and returning 18.6% for the past year while U.S. Treasury yields rose between 54-78 bps across the curve. Investors' reliance on accommodative monetary policies overcame elevated yields and kept the Bloomberg Barclays Aggregate Index in positive territory with a gain of 0.1%. Corporate credit outpaced the overall market with a return of 2.2% given a supportive technical backdrop of both strong inflows into domestic high grade funds and robust overseas demand for yield. High yield also benefitted from the quest for spread products, gaining nearly 9%. Among securitized issues, non-agency MBS continued to be well sponsored given still improving fundamentals as ongoing home price appreciation improved loan-to-value ratios. Asset-backed securities (ABS) gained 0.9% for the year, sustained by the standout performance of floating rate student loans as the subsector outpaced duration-matched Treasuries by over 600 bps amid the conclusion of downgrade reviews by rating agencies with results that were less negative than anticipated. Agency MBS returned 0.3%, but lagged Treasuries by 13 bps on a duration-adjusted basis given concerns over the Fed's plan for balance sheet reduction. Finally, commercial MBS fell 0.1% but produced excess returns over Treasuries of more than 120 bps, led by non-agency issues which were supported by lackluster issuance while the agency space was weighed down by abundant supply.

With demand for yield remaining the dominant market theme, technicals have generally superseded what we believe are deteriorating credit fundamentals. To this point, while the investment grade credit market has grown by 11%, or \$3.5 trillion, since 2009, EBITDA growth for the credit universe over the same period was only 1%. Given peak corporate leverage levels that are unlikely to meaningfully improve in the foreseeable future as record debt issuance shows no sign of slowing, combined with weakening issuance practices, our view with regards to credit exposure is particularly cautious even as spreads appear to be lacking foundation. Similarly, consumer ABS new issuance continued at a robust pace, led by auto and credit card deals, totaling \$174.6 billion year-to-date 2017, 13% higher than 2016 levels. Further, while the Fed's efforts to normalize rates and balance sheet levels have been well telegraphed thus far (with the latest announcement confirming that shrinking of the now \$4.5 trillion balance sheet will begin in October), there are significant risks to the outlook that should give investors pause. Other risks include Fed policy and monetary policy implementation, as up to five new Fed board members could be confirmed in the next year, including a new chair. On the fiscal side of things, expectations for broad-based fiscal stimulus have repriced lower as discussions on infrastructure spending have ceased and the prospect of comprehensive tax reform appear unlikely, with the latest Republican blueprint showing a set of targeted tax cuts that may only provide a modest boost to growth in the short-term while potentially adding as much as \$1-1.5 trillion on to the deficit.

Against these uncertainties, TCW remains true to a disciplined, value-based approach, reflected via a focus on higher quality, more defensive areas of the market. Ultimately, expectations for price adjustments to provide sufficient yield compensation for aggregated risks will inform portfolio repositioning and an increased risk budget. In the meantime, the Funds will maintain caution, while keeping up the yield profile through selective additions offering attractive risk-adjusted return profiles.

Emerging markets (EM) have benefited from a combination of high real growth and low inflation, and supportive technicals. Certainly, EM sovereign and corporate spreads are tight relative to history, but still appear cheap relative to developed market credit alternatives. Short of the usual range of tail risk events, there do not appear to be any obvious near term global catalysts that would trigger a significant sell-off in EM. Our base case is predicated upon a synchronous global recovery, modest upside in inflation and a gradual removal of monetary accommodation. Several of the risks we see include an unexpected acceleration in DM inflation, where the Fed is perceived as being behind the curve, in addition to US policy uncertainty and/or a reversal of flows.

US stocks surged 18.6% (S&P 500 total return index) during the year ending 9/30/17, as strong corporate earnings results more than compensated for volatility leading up the US presidential election and the subsequent lack of progress in achieving meaningful fiscal reforms. After six quarters of negative year-over-year earnings growth through the first half of calendar year 2016, corporate profits posted a string of quarterly gains, boosted by the rebound in energy prices as well as the weakening of the US dollar. Although the equity market experienced periodic, short-lived bouts of volatility related to concerns about the North Korean missile crisis, generally positive macroeconomic data releases, coupled with renewed hopes for tax reform, fueled a rally in risk assets, including stocks. The upward revision in second-quarter US GDP growth from 3.0% to 3.1% (QoQ annualized) provided further support to equity prices, while the weakness in retail sales, jobless claims, and home sales data was generally dismissed because of disruption from Hurricanes Harvey and Irma. Even a late-September speech by Fed Chairwoman Yellen, in which she effectively said it would be a mistake to hold off on raising interest rates while waiting for inflation to reach a 2% threshold, did little to dampen the equity market rally. In fact, the spike in the yield on the US 10 Year Treasury Note from its calendar YTD 2017 low of 2.04% in early September to 2.33% by month end coincided with the “risk-on” rally and the view of many equity investors that a normalization of Fed policy might be indicative of an improved economic outlook. Looking forward, stock market fundamentals appear reasonably encouraging given that corporate earnings have been on the upswing for the past few quarters as the economy has gained some strength and the US dollar has weakened. Congressional passage of the Trump administration’s proposed tax reform legislation would prove a powerful catalyst to corporate earnings, as one sell-side firm estimates that it would equate to roughly a 6% boost to S&P Operating EPS growth (Wolfe Research, 10/2/17). It is worth noting that while “growth” stocks have trounced “value” stocks YTD (the Russell 1000 Growth index has bested the Russell 1000 Value index by over 13%), value stocks outpaced their growth counterparts by about 1.5% in September, potentially signaling an expected rise in interest rates and an improved economic growth backdrop. Our view on the equity market is constructive over the medium-to-long term, yet we are mindful in the near-term that the stock market continues to show marked signs of complacency, with the CBOE Volatility Index remaining close to its all-time low as valuations hover near 13-year highs (per Bloomberg, the Price/Earnings ratio stands at around 18.5 times forward consensus earnings). We continue to believe that our emphasis on rigorous bottom-up stock research will serve our Fund shareholders well over the longer term even if political and macroeconomic developments in the near term may overshadow the compelling investment fundamentals of the stocks assembled in our US Equity Funds’ portfolios.

As always, the TCW Funds continue to stay focused on maintaining a consistent investment approach with a long term view. We believe the TCW Funds provide our shareholders with sound investment strategies at competitive expense ratios. On behalf of the Board of Directors and everyone at TCW, thank you for your continued support. We look forward to assisting you in reaching your financial goals.

REPORT OF THE RÉVISEUR D'ENTREPRISES AGRÉÉ

Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of TCW Funds (the "SICAV") and of each of its Sub-Funds, which comprise the statement of net assets and the statement of investments and other net assets as at September 30, 2017 and the statement of operations and the statement of changes in net assets for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements give a true and fair view of the financial position of TCW Funds and of each of its Sub-Funds as at September 30, 2017, and of the results of their operations and changes in their net assets for the year then ended in accordance with Luxembourg legal and regulatory requirements relating to the preparation and presentation of the financial statements.

Basis for Opinion

We conducted our audit in accordance with the EU Regulation N° 537/2014, the Law of 23 July 2016 on the audit profession (Law of 23 July 2016) and with International Standards on Auditing (ISAs) as adopted for Luxembourg by the "Commission de Surveillance du Secteur Financier" (CSSF). Our responsibilities under those Regulation, Law and standards are further described in the "Responsibilities of "Réviseur d'Entreprises Agréé" for the Audit of the Financial Statements" section of our report. We are also independent of the SICAV in accordance with International Ethics Standards Board for Accountants' Code of Ethics for Professional Accountants (IESBA Code) as adopted for Luxembourg by the CSSF together with the ethical requirements that are relevant to our audit of the financial statements, and have fulfilled our other ethical responsibilities under those ethical requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Key Audit Matters

Key audit matters are those matters that, in our professional judgment, were of most significance in our audit of the financial statements of the current period. These matters were addressed in the context of the audit of the financial statements as whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

Existence and valuation of OTC derivatives

Why the matter was considered to be one of most significance in the audit?	How the matter was addressed in the audit?
<p>Two Sub-Funds of TCW Funds are invested in OTC ("Over-the-counter") derivative instruments. These derivatives are Credit Default Swaps ("CDS") and OTC Options. We refer to Notes 13 and 14 to the financial statements for the description of the instruments held.</p> <p>The commitment on these investments is significant to the Sub-Funds' investment activity. Some of those OTC derivative instruments are neither directly held by the Custodian Bank nor kept by credit institutions but are contracts between the parties. This requires specific procedures by the Custodian Bank on the statements received from OTC derivative instruments' counterparties to ensure their existence and the correct manual accounting input after each transaction.</p> <p>The OTC derivative instruments are either valued on basis of directly observable market data or unobservable input based on management estimates. In connection with our audit of the financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is material inconsistent with the financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. If, based on the work we have performed, we concluded that there is a material misstatement of this other information, we are required to report this fact. We have nothing to report in this regards.

Responsibilities of the Board of Directors of the SICAV and Those Charged with Governance for the Financial Statements

The Board of Directors of the SICAV is responsible for the preparation and fair presentation of the financial statements in accordance with Luxembourg legal and regulatory requirements relating to the preparation and presentation of the financial statements, and for such internal control as the Board of Directors determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, the Board of Directors of the SICAV is responsible for assessing the SICAV's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the Board of Directors of the SICAV either intends to liquidate the SICAV or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the SICAV's financial reporting process

Responsibilities of the “Réviseur d’Entreprises Agréé” for the Audit of the Financial Statements

The objectives of our audit are to obtain a reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue a report of “Réviseur d’Entreprises Agréé” that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with the EU Regulation N° 537/2014, the Law of 23 July 2016 and with ISAs as adopted for Luxembourg by the CSSF will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the SICAV’s internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by the Board of Directors of the SICAV.
- Conclude on the appropriateness of Board of Directors of the SICAV’s use of the going concern basis of accounting of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the SICAV’s ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our report of “Réviseur d’Entreprises Agréé” to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our report of “Réviseur d’Entreprises Agréé”. However, future events or conditions may cause the SICAV to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

We also provide those charged with governance with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

From the matters communicated with those charged with governance, we determine those matters that were of most significance in the audit of the financial statements of the current period and are therefore the key audit matters. We describe these matters in our report unless law or regulation precludes public disclosure about the matter or when, in extremely rare circumstances, we determine that a matter should not be communicated in our report because the adverse consequences of doing so would reasonably be expected to outweigh the public interest benefits of such communication.

Report on Other Legal and Regulatory Requirements

We have been appointed as "Réviseur d'Entreprises Agréé" by the General Meeting of the Shareholders on January 31, 2017 and the duration of our uninterrupted engagement, including previous renewals and reappointments, is six years.

We confirm that the prohibited non-audit services referred to in the EU Regulation N° 537/2014, on the audit profession were not provided and that we remain independent of the SICAV in conducting the audit.

Notes to the financial statements

1 - General

The Fund was incorporated on December 7, 2011 for an unlimited period as a *société anonyme* under the laws of the Grand Duchy of Luxembourg and qualifies as an open-ended *société d'investissement à capital variable* under part I of the amended Law of December 17, 2010 relating to undertakings for collective investment in transferable securities.

At September 30, 2017, nine Sub-Funds are available to investors:

TCW Funds - TCW Emerging Markets Income Fund (launched on December 30, 2011)

TCW Funds - MetWest High Yield Bond Fund (launched on November 16, 2012)

TCW Funds - TCW Emerging Markets Local Currency Income Fund (launched on April 11, 2013)

TCW Funds - MetWest Total Return Bond Fund (launched on April 19, 2013)

TCW Funds - TCW Total Return Bond Fund (launched on April 19, 2013)

TCW Funds - MetWest Unconstrained Bond Fund (launched on September 12, 2014)

TCW Funds - TCW Select Equities Fund (launched on December 8, 2015)

TCW Funds - TCW US REIT Income Fund (launched on October 24, 2014)

TCW Funds - TCW Multi-Income US Equities Fund (launched on March 20, 2015)

By Circular Resolution dated October 18, 2016, the Board of Directors of the Fund decided to launch on October 25, 2016, the Class ICHE share within the Sub-Fund TCW Funds - MetWest Unconstrained Bond Fund.

By Circular Resolution dated December 13, 2016, the Board of Directors of the Fund decided to launch on December 20, 2016, the Classes IA-QD and IAHA-QD shares within the Sub-Fund TCW Funds - MetWest Unconstrained Bond Fund.

By Circular Resolution dated December 30, 2016, the Board of Directors of the Fund decided to launch on January 06, 2017, the Classes XXEHE, XXGHG-QD and XXU shares within the Sub-Fund TCW Funds - MetWest Unconstrained Bond Fund.

By Circular Resolution dated March 20, 2017, the Board of Directors of the Fund decided to reactivate on April 03, 2017, the Class OU share within the Sub-Fund TCW Funds - MetWest Unconstrained Bond Fund.

By Circular Resolution dated June 14, 2017, the Board of Directors of the Fund decided to force the redemption of the following share classes : the Class ATFHE share within the Sub-Funds TCW Funds - TCW Multi-Income US Equities Fund and TCW Funds - TCW Total Return Bond Fund.

CARNE Group has been appointed as external Management Company as from September 15, 2017.

The Management Company is a *société anonyme* established as a Luxembourg *société de gestion* on 17 September 2009 pursuant to Chapter 15 of the Law. The articles of incorporation of the Management Company have been lodged with the Luxembourg Trade and Companies' Register and have been published in the *Mémorial* on 4 November 2009. The articles of incorporation of the Management Company were most recently updated on 11 December 2015 and this amendment was published in the *Mémorial C* on 17 February 2016. The Management Company is registered with the Luxembourg Trade and Companies' Register under number B-148258.

2 - Significant accounting policies

2.1 Presentation of financial statements

The Financial Statements are prepared in accordance with generally accepted accounting principles in Luxembourg. They are presented in accordance with Luxembourg regulations relating to undertakings for collective investment in transferable securities.

For the purpose of establishing the combined financial statements, the Net Assets of the Fund shall be expressed in USD. For the purpose of this calculation, the Net Assets of each segregated Sub-Fund shall be converted into USD. The report shall comprise specific information on each Sub-Fund as well as consolidated information on the Fund.

Notes to the financial statements (continued)

All other communications to shareholders shall be done through a notice that will be either published in a Luxembourg newspaper and in newspapers of countries where the Fund's Shares are offered, or sent to the shareholders at their address indicated in the shareholders' register or communicated via other means as deemed appropriate by the Board of Directors of the Fund and if required by the Luxembourg Law, in *Recueil Electronique des Sociétés et Associations du Grand-Duché de Luxembourg* ("RESA").

2.2 Calculation of the Net Asset Value

The Shares are issued and redeemed at their Net Asset Value ("NAV") determined on each Valuation Day and calculated on the Calculation Day.

Given that the Sub-Funds are exposed to market fluctuations and the risks inherent to any investment, the value of the net assets (the "Net Assets") of the Sub-Funds will vary in consequence.

The Net Asset Value of each Class of Shares, calculated on each relevant Valuation Day, is expressed in its NAV Currency.

In each Sub-Fund, the Board of Directors may, but is not required to, issue more than one Class of Shares.

An Investor may be entitled, under certain conditions, to switch from one Class of Shares to another Class of Shares within the same or another Sub-Fund on any Valuation Day. The conversion of a Class of Shares into another Class of Shares is subject to certain restrictions, due to the specific features of the relevant Classes.

2.3 Valuation

The value of Transferable Securities, Money Market Instruments and any financial liquid assets and instruments which are quoted or dealt in on a stock exchange or on a Regulated Market or any Other Regulated Market is based on their last reported sales prices, or if no sales are reported, based on quotes obtained from a quotation reporting system, established market makers, or pricing services.

Short-term investments having a maturity of 60 days or less are generally valued at amortized cost whereby the securities or assets are valued at their cost of acquisition adjusted for amortization or premium or accretion of discount on those securities rather than at the current market value of those securities or assets.

Composite and modeled bank loan prices are provided daily by the Markit Group. In situations where there is no available vendor coverage from an independent third party pricing provider, the security price will be provided using a broker quote or derived from the benchmark pricing system. For a security priced using this system, a selected proxy comprised of a relevant security (i.e., U.S. Treasury Note) or benchmark (i.e., LIBOR) is combined with a multiplier, divisor or margin believed to best reflect changes in the market value of the security. The daily value of the security is based on changes to the market price of the assigned benchmark. Once each month, an independent review of prices produced by the benchmark system as well as a review of the benchmark selected to adjust the price is obtained from one or more dealers.

Interest rate swaps are fair valued using pricing models that are based on real-time intraday snap shots of relevant interest rate curves that are built using the most actively traded securities for a given maturity. The pricing models also incorporate cash and money market rates. In addition, market data pertaining to interest rate swaps are monitored regularly to ensure that interest rates are properly depicting the current market rate.

Credit default swaps are fair valued using pricing models that take into account, among other factors, information received from market makers and broker-dealers, default probabilities from index specific credit spread curves, recovery rates, and cash flows.

Total return swaps are fair valued using pricing models that take into account among other factors, index spread curves, nominal values, modified duration values and cash flows.

Transactions in foreign currencies are translated into the Base Currency of the Sub-Funds at exchange rates prevailing on the transaction dates.

Forward foreign exchange contracts are valued at the forward rate applicable at the Statement of Net Assets date for the period until maturity.

Foreign Exchange Options, Exchange traded options, futures and options on futures are valued at the settlement price determined by the relevant exchange.

Notes to the financial statements (continued)

Net realised gains and losses and net changes in unrealised gains and losses from forward foreign exchange contracts are recognised in the Statement of Operations and Changes in Net Assets.

Net realised gains and losses and net changes in unrealised gains and losses from financial futures contracts are recorded in the Statement of Operations and Changes in Net Assets.

Net realised gains and losses and net changes in unrealised gains and losses from options contracts are recorded in the Statement of Operations and Changes in Net Assets.

Net realised gains and losses and net changes in unrealised gains and losses from swaps are recorded in the Statement of Operations and Changes in Net Assets.

2.4 Techniques and Instruments Relating to Transferable Securities

For the purpose of hedging and efficient portfolio management, the Sub-Funds may undertake transactions relating to financial futures, (i.e. interest rate, currency, stock index and futures on Transferable Securities), warrants and options contracts traded on a Regulated Market, transactions relating to OTC options with highly rated financial institutions specialising in this type of transaction and participating actively in the relevant OTC market. Sub-Funds which undertake such transactions will bear specific costs associated to this type of transaction.

The Sub-Funds did not transact any of these instruments during the year ended September 30, 2017, except for the Sub-Fund TCW FUNDS - TCW Emerging Markets Local Currency Income Fund (the FX Option is an OTC instrument).

2.5 Income

Interest on Bonds is accrued on a daily basis and is recorded in the "Statement of Operations and Changes in Net Assets" in the caption "Interest on Bonds, net". Dividends are credited to income on the date upon which the relevant securities are first listed as "ex-dividend". Interest income is accrued on a daily basis.

2.6 TBA Commitments

The Sub-Funds may enter into "Mortgages to be announced" or "TBA" transactions which are commitments to purchase at a future date securities backed by new mortgage pools. TBA commitments are considered securities in themselves, and involve a risk of loss if the value of the security to be purchased or sold declines or increases prior to settlement date. Until delivery TBAs are technically accounted for as forward transactions. Unsettled TBA commitments are therefore valued at the current market value of the underlying securities, according to the procedures described in Note 2.3 under "Valuation" and are recorded under "Payable for securities purchased". As at September 30, 2017, the TCW Funds – MetWest Total Return Bond Fund had net unsettled TBA commitment purchases in the amount of USD 25 512 964. These TBA positions were 100% collateralized by cash or cash equivalents (Agency Discount Notes, T-Bills, CP, US Government securities maturing within 2 years) and did not create leverage for the Sub-fund.

3 - Management fees

The Company shall pay to the Investment Manager an annual management fee, which shall be calculated in accordance with the provisions. The remuneration of its services as provided for by the present Agreement, the Investment Manager shall be entitled to receive a management fee of a percentage (as specified below) on a monthly basis in arrears and calculated for each Class of Shares within each Sub-Fund on the average of the Net Asset Value of each Sub-Fund over the period.

The Service Fee is calculated and is accrued on each Valuation Day and payable monthly in arrears to the Investment Manager. This Service Fee may be used by the Investment Manager to pay fees of other service providers such as:

- a. Administrative Agent, Domiciliary Agent and Registrar Agent;
- b. Custodian, including transaction fees;
- c. Auditors, legal advisers and local representatives;
- d. Creation and distribution of shareholders' materials;
- e. Governmental agencies and jurisdictional applicable fees.

For the avoidance of doubt, the Fund will not pay any fees directly to the custodian, administrative agent and registrar agent. Such fees will be borne by the Investment Manager. The Investment Manager implemented the fixed percentage fee structure in an effort to provide prospective investors with an immediate understanding of the servicing cost charged to the Fund.

6 - Brokerage and Transaction Costs

The Fund or each Sub-Fund, as applicable, shall pay out of its assets all brokerage commissions and transaction charges and costs incurred in connection with its operations.

None of the Investment Manager or Investment Sub-Manager may retain cash or other rebates from a broker or dealer in consideration of directing transactions to them.

Consistent with best execution, brokerage commissions on portfolio transactions for the Fund may be directed by the Investment Manager or its Connected Persons to broker-dealers in recognition of research services furnished by them as well as for services rendered in the execution of orders by such broker-dealers.

9 - Taxation

In accordance with the legislation currently prevailing in Luxembourg, the Fund is not subject to any taxes on income or capital gains. The Fund is subject to a subscription tax *Taxe d'abonnement*, which amounts to an annual rate of 0.05% based on the Net Asset Value of each Sub-Fund at the end of each calendar quarter, calculated and paid quarterly. However, this tax is reduced to 0.01% for Net Asset Value related to units classes only aimed at eligible institutional investors and for Sub-Funds whose sole object is collective investment in money market instruments and in deposits with credit institutions.

Pursuant to Article 175 (a) of the amended law of 17 December 2010, the net asset invested in UCIs already subject to *Taxe d'abonnement* is exempted from this tax.

Interest and dividend income received by the Fund may be subject to non-recoverable withholding tax in the countries of origin.

Global risk exposure

In terms of risk management, the Board of Directors of the Fund selected the commitment approach in order to determine the global risk for all Sub-Funds.

SFTR Regulation

As at September 30, 2017, the Fund does not invest in instruments in the scope of the requirements of the Regulation (EU) 2015/2365 on transparency of Securities Financing Transactions and of Reuse ("SFTR"). Furthermore, no corresponding transactions were carried out during the year referring to the financial statements.

Remuneration Policy

The Management Company has designed and implemented a remuneration policy (the "Remuneration Policy") in line with the provisions on remuneration as set out by the European Directive 2009/65/EC ("UCITS Directive"), as amended by Directive 2014/91/EU ("UCITS V Directive") as implemented into Luxembourg in the Law of 10 May 2016 (the "2016 Law").

The Management Company has developed and implemented remuneration policies and practices that are consistent with and promote a sound and effective risk management of the Fund, do not encourage risk-taking which is inconsistent with the risk profiles/rules governing the Fund, and do not impair compliance with the Management Company's duty to act in the best interest of the Fund and ultimately its investors.

The Board of Directors of the Management Company is responsible for the design and implementation of the Remuneration Policy and reviews this on a regular basis as part of its supervisory function. In reviewing the Remuneration Policy, the Board of Directors of the Management Company will consider whether the remuneration framework operates as intended and that the risk profile, long-term objectives and goals of the Fund are adequately reflected.
