### Objectives and investment policy

The Fund aims to grow the value of your investment over the long term.

The Fund invests primarily in a mix of assets including: company shares; bonds (contracts to repay borrowed money which typically pay interest at fixed times); property; commodities; money market instruments (types of tradable securities where cash can be deposited for short periods); cash; and alternative asset classes. The issuers of these investments will be either in emerging markets (countries that are in economic terms less developed than the major Western countries) or those which carry out a significant proportion of their business activities in these markets. Investment may be directly in the assets themselves (except for property and commodities) or indirectly through other funds or derivatives (financial contracts whose value is linked to the price of an underlying asset).

The bonds and money market instruments are issued by governments, institutions or companies.

Normally no more than 75% of the Fund is exposed, directly or indirectly, to the shares of companies.

The Investment Manager is free to choose how the Fund is invested and does not manage it with reference to an index.


Any income due from your investment is reflected in the value of your shares rather than being paid out.

You can buy or sell shares in the Fund on any business day in both the UK and Luxembourg, as defined in the prospectus (section 3).

### Risk and reward profile

### Charges

The ongoing charges figure shown here is an estimate of the charges, as there has been a change to the charging structure. The Fund's annual report for each financial year will include detail on the exact charges made. The figure excludes any performance fee and portfolio transaction costs, except in the case of an entry or exit charge paid by the Fund when buying or selling units in another fund. Ongoing charges may vary from year to year.


### Past performance
