Investment Manager's Report

For the 6 month financial period ended 31 December 2016

The reporting period began with a huge political surprise as UK voters decided to turn their backs on the European Union. Continuing their upward trajectory, markets shrugged off this disappointment in a matter of days. 2H 2016 had many parallels with the first half, with riskier assets and the energy sector still large return drivers. In fact, CCC securities tightened by 50% in the ten months from February to December 2016 inclusive, a staggering 14% greater tightening than in the last period of outperformance of CCC-rated assets, over a period three times as long from November 2011 to July 2014. CCC securities ended 2016 up over 36%, more than double the return of the BofA Merrill Lynch US High Yield Index (H0A0). Even more remarkably, lower-quality bonds priced below \$70 posted a performance number within a whisker of 90%. Moreover, distressed assets (defined as those with a spread over 1000 bps) plummeted from over 30% of the H0A0 in February 2016 to below 7% by year end.

As for energy, there has been an interesting bifurcation between WTI prices and the average high yield energy bond price (measure by the H0EN index) since June 2016. Whilst oil prices have seen more volatility in 2H 2016, security prices have continued to move higher, helped by equity issuance, debt extensions and a generally more prosaic prognosis for the sector. Defaults have been skewed to the commodities sector and recovery rates have fallen dramatically from historical averages, largely fuelled by energy and metals & mining. Many energy names fell into the fallen angels sector, which was another area of the market representing a strong performance driver, although its impact was more noticeable in 1H 2016.

An even more seismic political event took place in the US on November 9th, although the unexpected election of Donald Trump as US President caused less of a market stir than even Brexit. Indeed, the market seems to anticipate Trump's election heralds the onset of higher economic growth, fewer regulations, infrastructure spending, capital inflows and earnings momentum. These potential positive factors will of course take time to materialise and there are consequences. Higher growth could fuel inflation, in turn leading to higher rates. However, High Yield (HY) should be relatively well positioned vs Investment Grade (IG) due to its shorter duration. In addition, a strong economy is positive for lower defaults and leveraged debt normally outperforms fixed income in these environments. International investors are likely to seek attractive income streams from dollar-denominated assets.

Although a backdrop of higher rates could slow bond issuance for refinancing, the wild card is acquisition financing. As a percentage of high yield issuance proceeds, acquisition finance fell from 37.5% to 15.5% between 2015 and 2016, in favour of refinancing which rose from 43.4% to 58.2% during the same period. This trend could reverse in 2017. Loan issuance increased rapidly in 2H 2016, with a significant portion being earmarked for LBOs and private equity firms have substantial amounts of undrawn capital ready for investment. Finally, 2H 2016 was also characterized by LIBOR approaching 1%, leading to loan inflows and greater CLO activity, which is a positive sign for the extension of the credit cycle.

Investment Manager's Report (continued)

The Shenkman Finsbury High Income Fund and Shenkman Finsbury High Income Short Duration Fund have performed largely in-line with expectations during 2H 2016. Both funds offered meaningful downside protection during the market downturn in the second half of 2015 and early weeks of 2016, but lag the broader market in periods where lower-quality credits rally indiscriminately. We are underweight Energy, CCC securities and fallen angels, all of which posted outsized returns. We believe our preference for single B securities will be additive in 2017, as historically this ratings bucket has outperformed the year after a double digit market return, whereas CCCs typically registered negative returns or underperformed in these periods.

The Shenkman Finsbury High Income Fund Class A US\$ Accumulating Share Class produced a net return (65 bps) of 5.71% for 2H 2016, while the H0A0 returned 7.47%. The Fund remained well-diversified with holdings in 230 issuers. Key portfolio metrics include a 5.46% yield-to-worst, an average credit rating of B2/B+, and a high quality profile with a C.Scope® credit score of 81.20.

The Shenkman Finsbury Short Duration High Income Fund Class A US\$ Accumulating Share Class produced a net return (55 bps) of 2.42% for 2H 2016, while the BofA Merrill Lynch 0-2 Year Duration-to-Worst BB-B High Yield Constrained Index (H42C) returned 2.95% and the BofA Merrill Lynch 0-3 Year U.S. Treasury Index (G1QA) returned -0.30%. The Fund ended December with a current yield of 5.78% and duration-to-worst of 1.25 years. The portfolio maintained its more conservative positioning and shorter average duration than the broader high yield market, represented by H0AO Index, which ended the period with a duration-to-worst of 3.95 years.

In 2H 2016, the Shenkman Finsbury Global Convertible Bond Fund Class A US\$ Accumulating Share Class operated free of its restriction limiting non-US investments to up to 25%. It produced a net return of 3.95% for 2H 2016, while the BofA Merrill Lynch Global 300 Convertible Index (VG00) returned 7.03%. At the end of 2016, the fund had exposure to 70 issuers across 31 industries. European converts underperformed their US peers in 2016, although the region dominated the new issue market.

Shenkman is delighted to announce the successful launch of Shenkman Finsbury Global High Yield Bond Fund under the offering in December 2016. This product was seeded by three existing investors and allows us to expand our global capabilities and benefit from the additional resource of the European high yield team we acquired from Brookfield in 2014. Shenkman now has global capabilities in high yield, short duration and convertibles, which we hope will appeal to investors in the US, Europe and Asia.

Notes to the financial statements

1. Establishment and Organisation

Shenkman Finsbury Credit Fund plc (the "Company") is an open-ended umbrella investment Company with segregated liability between Sub-Funds and variable capital incorporated in Ireland as a public limited company on 15 June 2011 under registration number 499990.

As of 31 December 2016, the Company had four active Sub-Funds (each a "Sub-Fund" and together the "Sub-Funds"):

- Shenkman Finsbury High Income Fund,
- Shenkman Finsbury Short Duration High Income Fund,
- Shenkman Finsbury Global Convertible Bond Fund,
- Shenkman Finsbury Global High Yield Bond Fund.

The Shenkman Finsbury High Income Fund was launched on 1 July 2011, the Shenkman Finsbury Short Duration High Income Fund was launched on 25 August 2011, the Shenkman Finsbury Global Convertible Bond Fund was launched on 21 May 2015, and the Shenkman Finsbury Global High Yield Bond Fund was launched on 16 December 2016. The Company had no employees for the financial period ended 31 December 2016 and for the financial year ended 30 June 2016.

The investment objective of the Shenkman Finsbury High Income Fund is to seek to achieve maximum total return (i.e., both enhancing current income and achieving capital appreciation) by investing primarily in fixed income, high yield securities predominantly issued by U.S. issuers that are denominated in U.S. Dollars.

The investment objective of the Shenkman Finsbury Short Duration High Income Fund is to seek to achieve high current income. The Sub-Fund seeks to achieve its objective by investing a majority of its Net Asset Value in a portfolio of fixed income and high yield securities (i.e., Below Investment Grade Securities). While the Sub-Fund will have an overall targeted Duration of three years or less, it may purchase and hold securities of any Duration and of any quality, rated or unrated.

The investment objective of the Shenkman Finsbury Global Convertible Bond Fund is to seek to maximise total returns on a risk-adjusted basis (i.e., enhance current income and achieve capital appreciation) by investing primarily (i.e., at least 70 per cent of its Net Asset Value) in convertible securities that are issued by companies worldwide.

The investment objective of the Shenkman Finsbury Global High Yield Bond Fund is to seek to maximise total returns on a risk-adjusted basis (i.e., enhance current income and achieve capital appreciation) by investing primarily (i.e., at least 70 per cent of its Net Asset Value) in high yield bond securities that are issued by companies worldwide.

2. Significant Accounting Policies and Basis of Preparation

(a) Significant Accounting Policies

The significant accounting policies and estimation techniques adopted by the Company for the 6 month financial period ended 31 December 2016 are consistent with those adopted by the Company for the annual audited financial statements for the financial year ended 30 June 2016.

(b) Basis of preparation

The condensed semi-annual financial statements for the 6 month financial period ended 31 December 2016 have been prepared in accordance with IAS 34, 'Interim Financial Reporting', European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations, 2011 (as amended) (the "UCITS Regulations") and the Central Bank (Supervision and Enforcement) Act 2013 (Section 48(1)) (Undertakings for Collective Investment in Transferable Securities) Regulations 2015 (as amended) (the "Central Bank UCITS Regulations") and in accordance with the requirements of the Companies Act, 2014.

Notes to the financial statements (continued)

3. Fair Value of Financial Instruments

Fair value is the amount for which an asset could be exchanged, or a liability settled, between knowledgeable, willing parties in an arm's length transaction on the measurement date.

When available, the Company measures the fair value of an instrument using quoted prices in an active market for that instrument. A market is regarded as active if quoted prices are readily and regularly available and represent actual and regularly occurring market transactions on an arm's length basis. These instruments are included within level 1 of the fair value hierarchy.

Financial instruments, other than those listed and actively traded on an official stock exchange, are valued by independent pricing services based on pricing models. The models also take into consideration data received from active market makers and broker-dealers, yield curves, and the spread over comparable bond issues. The spreads change daily in response to market conditions and are generally obtained from the new issue market and broker dealer sources. Shenkman Finsbury Global Convertible Bond Fund holds convertible bonds. The investment value of a convertible security is influenced by changes in interest rates, with investment declining as interest rates increase and increasing as interest rates decline. The conversion value of a convertible security is determined by the market price of the underlying common stock. To the extent that these inputs are observable, the values of these bonds are categorised within level 2 of the fair value hierarchy, as well as corporate bonds and loan notes.

The fair values of forward foreign currency contracts are calculated by reference to current exchange rates for contracts with similar maturity and risk profiles. To the extent that these are observable, the values of those forward foreign currency contracts are classified within level 2 of the fair value hierarchy.

The determination of fair value for financial assets and liabilities for which there is no observable market price requires valuation techniques. IFRS 7 "Financial Instruments Disclosures", establishes a fair value hierarchy for inputs used in measuring fair value that maximises the use of observable inputs and minimises the use of unobservable inputs by requiring that the most observable inputs be used when available. Observable inputs are those that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Company. Unobservable inputs reflect the Company management's assumptions, made in good faith, about the inputs market participants would use in pricing the asset or liability developed based on the best information available in the circumstances. The fair value hierarchy is categorised into three levels based on the inputs as follows:

Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities;

Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, either directly (as prices) or indirectly (derived from prices); and

Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

Inputs are used in applying the various valuation techniques and broadly refer to the assumptions that market participants use to make valuation decisions, including assumptions about risk. Inputs may include price information, volatility statistics, specific and broad credit data, liquidity statistics, and other factors. A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. However, the determination of what constitutes "observable" requires significant judgement by the Company.

The Company considers observable data to be market data which is readily available, regularly distributed or updated, reliable and verifiable, not proprietary, and provided by independent sources that are actively involved in the relevant market. The categorisation of a financial instrument within the hierarchy is based upon the pricing transparency of the instrument and does not necessarily correspond to the Company's perceived risk of that instrument.

Notes to the financial statements (continued)

3. Fair Value of Financial Instruments (continued)

Fair value is a market-based measure considered from the perspective of a market participant rather than an entity-specific measure. Therefore, even when market assumptions are not readily available, the Company's assumptions are set to reflect those that market participants would use in pricing the asset or liability at the measurement date. The Company uses prices and inputs that are current as of the measurement date, including periods of market dislocation. In periods of market dislocation, the observability of prices and inputs may be reduced for many securities. This condition could cause a security to be reclassified to a lower level within the fair value hierarchy.

The assets and liabilities included in the above tables are carried at amortised cost; their carrying values are a reasonable approximation of fair value.

Cash comprises cash on hand and demand deposits. Cash equivalents are short term, highly liquid investments that are readily convertible to known amounts of cash and which are subject to insignificant changes in value with a maturity of three months or less. As such, level 1 has been deemed the most appropriate categorisation for each Sub-Fund's cash and cash equivalents.

Bond interest and other income receivable, receivable on subscriptions, receivable on sale of investments and other receivables represent the contracted amounts for settlement of trades and other obligations due to each Sub-Fund.

Administration fees, management fees, depositary fees, payable on purchase of investments, payable on redemptions and other expenses payable represent the contractual amounts and obligations due by each Sub-Fund for settlement of trades and expenses.

The puttable value of net assets attributable to holders of redeemable participating shares is calculated based on the net difference between total assets and all other liabilities of the relevant Sub-Fund in accordance with the Sub-Fund's offering documents. The redeemable participating shares are not traded in an active market. A demand feature is attached to net assets attributable to redeemable participating shares as a shareholder can redeem from each relevant Sub-Fund on any dealing day for cash equal to a proportionate share of the relevant Sub-Fund's net asset value. The fair value is based on the amount payable on demand, discounted from the first date that the amount could be required to be paid. The impact of discounting in this instance is not material.

As such, level 2 has been deemed the most appropriate classification for each Sub-Fund's receivables, payables and net assets attributable to holders of redeemable participating shares as noted above.

Notes to the financial statements (continued)

4. Distributions

The Directors intend to declare dividends in respect of certain Class A and Class B Shares of the Sub-Funds ("Distributing Share Classes"). Other than in respect of the Distributing Share Classes, it is intended that, in the normal course of business, distributions will not be declared in respect of any other Classes of Shares ("Accumulating Share Classes") and that any net investment income and realised and unrealised capital gains net of realised and unrealised capital losses attributable to each Accumulating Share Class will be accumulated in the respective Net Asset Value per Share of each respective Class of Shares and will be reinvested in accordance with the investment objectives and investment policies of the relevant Sub-Fund.

In respect of the Distributing Share Classes, the Directors intend to declare a dividend on a quarterly basis as of each 31 March, 30 June, 30 September and 31 December. Dividends have been declared or paid in respect of the financial period ending 31 December 2016 and 31 December 2015 as follows;

5. Taxation

Under current Irish law and practice, the Company qualifies as an investment undertaking for the purposes of Section 739B of the Taxes Consolidation Act 1997, as amended as long as the Company is resident in Ireland. On that basis, it is generally not chargeable to Irish tax on its income and gains.

However, Irish tax can arise on the happening of a "chargeable event" in the Company. A chargeable event includes any payments of distributions to Shareholders, any encashment, repurchase, redemption, cancellation or transfer of Shares and any deemed disposal of Shares as described below for Irish tax purposes arising as a result of holding Shares in the Company for a period of eight years or more. Where a chargeable event occurs, the Company is required to account for the Irish tax thereon.

No Irish tax will arise in respect of a chargeable event where:

- (a) the Shareholder is neither resident nor ordinarily resident in Ireland ("Non-Irish Resident") and it (or an intermediary acting on its behalf) has made the necessary declaration to that effect and the Company is not in possession of any information which would reasonably suggest that the information contained in the declaration is not, or is no longer, materially correct; or
- (b) the Shareholder is Non-Irish Resident and has confirmed that to the Company and the Company is in possession of written notice of approval from the Revenue Commissioners to the effect that the requirement to provide the necessary declaration of non-residence has been complied with in respect of the Shareholder and the approval has not been withdrawn; or
- (c) the Shareholder is an 'Exempt Irish Resident' as defined in the Prospectus.

Dividend, interest and capital gains (if any) received on investments made by the Company may be subject to withholding tax imposed by the country from which the investment income/ gains are received and such taxes may be recoverable by the Company or its Shareholders.

6. Cash and Cash Equivalents

Cash comprises current deposits with banks and short-term money market investments. Cash equivalents are short-term highly liquid investments that are readily convertible to known amounts of cash, are subject to low levels of market price risk, and are held for the purpose of the meeting short-term cash commitments rather than for investments or other purposes.

8. Financial Risk Management

The Company's investment activities expose it to various types of risk that are associated with the financial instruments and markets in which it invests. The following information is not intended to be a comprehensive summary of all risks and investors should refer to the Company's Prospectus and supplements for a more detailed discussion of the inherent risks of investing in the Company.

The Board reviews quarterly investment performance reports and receives quarterly presentations from the Investment Manager covering each Sub-Fund's performance and risk profile during the financial period. The Board reviews and has agreed the policies for managing the Company's risks. These policies have remained substantially unchanged since the beginning of the financial period to which these financial statements relate. The Investment Manager has been engaged to manage the risks of the Company. Details of all risks can be found in the Prospectus and supplements.

The risk exposure of the Company is set out as follows:

(a) Market risk

Market risk arises mainly from uncertainty about future values of financial instruments influenced by price, currency and interest rate movements. It is a general risk that represents the potential loss the Company may suffer through holding market positions in the face of market movements. The Company is exposed to market risk primarily by virtue of its investment into fixed and variable corporate bonds, convertible bonds and loan notes.

Notes to the financial statements (continued)

8. Financial Risk Management (continued)

(a) Market risk (continued)

The Investment Manager generally considers the asset allocation of the portfolio in order to minimise the risk associated with particular countries or industry sectors whilst continuing to follow each Sub-Fund's investment objective. The Company's market risk is managed on a daily basis by the Investment Manager in accordance with policies and procedures in place.

Global Exposure to Financial Derivative Instruments

The Investment Manager has assessed the risk profile of the Company and the related Sub-Funds on the basis of the investment policy, strategy and the use of financial derivative instruments.

Based on the risk profile, the Investment Manager has determined that the method for the calculation of the global exposure to financial derivative instruments for all Sub-Funds will be the commitment approach, where the Sub-Fund holds financial derivative instruments.

Breaches of the exposure limits, if any, are identified using commitment approach, addressed by the Investment Manager and reported to the Board of Directors. An annual Financial Derivative Instruments ("FDI") report is provided to the Central Bank detailing any exposure breaches in either the global exposure or counterparty risk exposure in respect of Financial Derivative Instruments.

During the financial period ended 31 December 2016 and for the financial year ended 30 June 2016 there were no breaches of the Financial Derivative Instruments exposure limits.

(b) Credit risk

The Company invests primarily in debt securities that have a non-investment grade rating as determined by Standard and Poor's (S&P) or Moody's ("high yield securities"). These investments are subject to greater credit risks than investment grade debt securities. The risk of loss due to default by issuers of high yield securities is significantly greater because medium and lower rated securities and unrated securities of comparable quality generally are unsecured and frequently are subordinated to the prior payment of senior indebtedness. Consequently, issuers of high yield securities are less likely to be able to make interest payments on their debt than issuers of investment grade securities. So there is greater risk for a Sub-Fund to lose all or a portion of its investment.

The Company's credit risk is managed on a daily basis by the Investment Manager in accordance with policies and procedures in place, including, without limitation, a review of the issuer's financial resources, its sensitivity to economic conditions and trends, the operating history of and the community support for the facility financed by the issue, the ability of the issuer's management and regulatory matters.

Offsetting

There were no master netting agreements in place for the financial period ended 31 December 2016 (30 June 2016: none). As a result the requirements of IFRS 7 to disclose offsetting positions of financial assets and liabilities have no impact on current disclosures in the Company's financial statements.

Notes to the financial statements (continued)

8. Financial Risk Management (continued)

(c) Interest rate risk

Interest rate risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in prevailing interest rates. The Company is exposed to interest rate risk through its investments in securities with fixed and floating rates of interest and its cash balances. High yield securities as an asset class have traditionally been less sensitive to interest rate risk relative to other asset classes such as investment grade bonds. However, when interest rates decline, the value of a Sub-Fund's portfolio invested in fixed-rate obligations can be expected to rise. Conversely, when interest rates rise, the value of a Sub-Fund's portfolio investments in fixed-rate obligations can be expected to decline. To mitigate the negative impact of a rising interest rate environment, the Investment Manager manages the Company's interest rate risk on a daily basis in accordance with policies and procedures in place.

(d) Liquidity risk

Liquidity risk exists when a particular instrument is difficult to purchase or sell or when there is a need to meet redemption requests from Shareholders. If a transaction is particularly large or if the relevant market is illiquid, it may not be possible to initiate a transaction or liquidate a position at an advantageous price.

Liquidity risk is assessed by the Investment Manager in its review of the risk profile of the Sub-Funds. The Sub-Funds deal daily and their investments largely comprise high yield debt instruments traded on regulated markets. Still, the secondary markets may be less liquid for these securities, which at certain times may: (i) affect their value; (ii) make their valuation and sale more difficult; and (iii) result in greater volatility. The Investment Manager seeks to mitigate the Company's liquidity risk by diversifying the underwriters/market-makers through which it effectuates transactions and limiting the amount of any one issue purchased.

(e) Foreign Currency Risk

Foreign currency risk is the risk that the Company's operations or the net asset value of a Sub-Fund will be affected by changes in exchange rates and regulatory controls on currency movements.

The Company is exposed to share class currency risk whereby there is currency exposure at the share class level for all share classes that are denominated in a different currency than the functional currency of the Company (US\$). This means that changes in currency exchange rates may cause the value of non-US\$ share classes to decrease even if the value of the Company's investments increases. The Company manages this risk with respect to "hedged" share classes only through the use of forward foreign currency contracts. Gains or losses on these forward foreign currency contracts are allocated to the hedged share classes.

(f) Counterparty Credit and Custody Risk

Counterparty Credit risk is the risk that the counterparty or issuer to a financial instrument will fail to discharge an obligation or commitment that it has entered into with the Company. The Company is exposed to counterparty credit risk with respect to each Sub-Fund. Furthermore, the Company is exposed to counterparty risk with respect to all counterparties with whom the Sub-Funds trade and bears the risk of settlement default. Counterparty risk is still relevant and is assessed by the Investment Manager in its review of the risk profile of the Company.

All transactions involving transferable securities are settled upon delivery using approved brokers. The risk of default is considered minimal, as delivery of securities sold is only made once the counterparty has received payment. Payment is made on a purchase once the securities have been received by the counterparty. A trade will fail if either party fails to meet its obligations.

9. Fees

Investment Management Fees

The Investment Manager is entitled to receive, out of the assets of each Sub-Fund, an investment management fee accrued at each Dealing Day (as defined in the Company's Prospectus) and payable monthly in arrears, of up to 1 per cent per annum of the Net Asset Value of the Fund with respect to the Class A shares and up to 1.5 per cent per annum with respect to the Class B shares.

During the financial period, the Investment Manager voluntarily agreed to impose a 85 basis point cap on expenses of the Shenkman Finsbury Global Convertible Bond Fund (up to 30 November 2016 inclusive) and of the Shenkman Finsbury Global High Yield Bond Fund (from 16 December 2016). Any expenses over this cap were paid by the Investment Manager.

Shenkman Finsbury High Income Fund

Investment Management Fees for the financial period amounted to US\$4,093,820 (31 December 2015: US\$4,241,616). Fees outstanding as at 31 December 2016 were US\$631,697 (30 June 2016: US\$677,102).

Shenkman Finsbury Short Duration High Income Fund

Investment Management Fees for the financial period amounted to US\$3,387,379 (31 December 2015: US\$2,991,304). Fees outstanding as at 31 December 2016 were US\$560,902 (30 June 2016: US\$526,790).

Shenkman Finsbury Global Convertible Bond Fund

Investment Management Fees for the financial period amounted to US\$418,517 (31 December 2015: US\$102,804). Administration and Depositary Fees

The Administrator is entitled to receive, out of the assets of each Sub-Fund, an administration fee accrued at each Dealing Day and payable monthly in arrears, of up to 0.0225% per annum of the Net Asset Value of each Sub-Fund subject to a minimum fee of US\$50,000 per annum per Sub-Fund.

The Depositary is entitled to receive, out of the assets of each Sub-Fund, a depositary fee accrued at each Dealing Day and payable monthly in arrears, of up to 0.014375% per annum of the Net Asset value of each Sub-Fund, subject to a minimum fee of US\$23,000 per annum, calculated and invoiced monthly, and to certain transaction charges which shall be charged at normal commercial rates. The Depositary disburses out of its own fee all Sub-Custodian charges arising in respect of the Sub-Funds. The Depositary is entitled to an additional fixed fee of US\$1,000 per Sub-Fund for Investor Money Regulations services effective from 1 July 2016.

Formation expenses, being the costs associated with the establishment and launch of the Company or any class of shares or Company interests issued by the Company, are amortised over a five year period in accordance with the Prospectus. Formation expenses associated with the establishment of a new Sub-Fund are borne by that Sub-Fund. The accounting treatment for formation expenses prescribed by IFRS indicates that formation expenses, where material, should be written off as incurred in the financial statements.

All other operating expenses are recognised in the Statement of Comprehensive Income on an accruals basis.

Directors' Fees

The Articles of Association provide that the Directors are entitled to a fee by way of remuneration for their services at a rate to be determined from time to time by the Directors. Employees, partners and officers of the Investment Manager and its affiliates are not entitled to receive Directors' fees. The Directors are also entitled to be reimbursed by the Company for all reasonable disbursements and out-of-pocket expenses incurred by them, if any.

Directors' remuneration for the financial period amounted to US\$28,477 (31 December 2015: US\$25,835).

10. Exchange Rates

Currencies or values in currencies other than in the designated currency of the Company will be translated or converted into the said designated currency at the closing rates of exchange at each financial period end. 11. Share Capital

Each of the redeemable participating shares (the "Shares") entitles the Shareholder to participate on a pro rata basis in the dividends and net assets of the Company attributable to the relevant class in respect of which they are issued, save in the case of dividends declared prior to becoming a Shareholder. The Subscriber Shares' entitlement is limited to the amount subscribed and accrued interest thereon.

The Shares do not represent the most 'subordinate' class of instrument and are classified as financial liabilities. The Shares have priority over other claims to the assets of the entity on liquidation. The Shares can be put back into each Sub-Fund on any Dealing Day for cash equal to a proportionate share of the Sub-Fund's net asset value. Each Sub-Fund generally provides its Shareholders with the right to redeem their interests in the Sub-Fund at any dealing date for cash equal to their proportionate share of the net asset value of that Sub-Fund. Under IAS 32: 'Financial Instruments: Disclosure and Presentation', this right represents in substance a liability of the Sub-Fund to Shareholders.

Shenkman Finsbury High Income Fund, Shenkman Finsbury Short Duration High Income Fund, Shenkman Finsbury Global Convertible Bond Fund and Shenkman Finsbury Global High Yield Bond Fund each deal daily. An anti-dilution levy may be applied to the subscription and/or redemption price of Shares on any Dealing Day where there have been net subscriptions/redemptions by adding/deducting therefrom such a figure as the Investment Manager considers appropriate to cover dealing costs and to preserve the value of the underlining assets of the relevant Fund. Any amount added to a subscription price or deducted from a redemption price will be paid into the assets of the relevant Fund. The anti-dilution levy shall not exceed 2% of the subscription monies obtained on the dealing day which the subscription is effected.

Notes to the financial statements (continued)

11. Share Capital (continued)

An anti-dilution levy of up to 0.64% was applied to net subscriptions into the Shenkman Finsbury Short Duration High Income Fund (31 December 2015: 0.64%). An anti-dilution levy of up to 0.70% was applied to net subscriptions into the Shenkman Finsbury Global Convertible Bond Fund (31 December 2015: none). There was no anti-dilution levy applied on the Shenkman Finsbury High Income Fund and Shenkman Finsbury Global High Yield Bond Fund during the period. The anti-dilution levy earned during the financial period is detailed in the Statement of Comprehensive Income.

12. Soft Commissions

The Company did not engage in any soft commission transactions during the financial period ended 31 December 2016 and 31 December 2015.

13. Related Party Transactions

Parties are considered to be related if one party has the ability to control the other party or exercise significant influence over the other party in making financial or operational decisions, or if the party is a member of the key management personnel of the entity or its parent.

As at 31 December 2016, the Investment Manager is deemed to be a related party of the Company. For details relating to the fees paid to the Investment Manager please see Note 9.

The Investment Manager has the ability to execute "cross trades" between the Company's Sub-Funds and other client accounts it manages. During the financial period, the Investment Manager purchased 95 securities on behalf of the Shenkman Finsbury Short Duration High Income Fund from other Client accounts managed by the Investment Manager with an aggregate trading volume of US\$45,641,881. During the financial period, the Investment Manager also purchased 33 securities on behalf of the Shenkman Finsbury High Income Fund from other client accounts managed by the Investment Manager with an aggregate trading volume of US\$9,139,962. During the financial period, the Investment Manager also sold 2 securities on behalf of the Shenkman Finsbury High Income Fund to other client accounts managed by the Investment Manager with an aggregate trading volume of US\$964,341. The Investment Manager did not receive any fees or commissions in connection with these transactions. All cross trades notified by the Investment Manager during the reporting period have been reviewed by the Depositary.

Shenkman Finsbury Global High Yield Bond Fund was launched on 16 December 2016 following an in-specie transfer from Shenkman Finsbury High Income Fund. The value of assets transferred to the Shenkman Finsbury Global High Yield Bond Fund was US\$48,848,588.

The Company has entered into a Facilities Agent Agreement with Shenkman Capital Management LTD, pursuant to which Shenkman Capital Management LTD serves as the facilities agent to the Company for the purpose of providing and maintaining the facilities required of a recognised collective investment scheme in the United Kingdom. Shenkman Capital Management LTD is a wholly-owned subsidiary of the Investment Manager. The Company pays Shenkman Capital Management LTD a fee of £4,000 (approximately US\$5,106) per annum for its services as facilities agent.

Mark R. Shenkman is a principal officer of the Investment Manager. Frank X. Whitley is Vice Chairman and Senior Advisor of the Investment Manager. Teddy Otto and Yvonne Connolly are employees of Carne Global Financial Services Ltd ("Carne"), which acts as company secretary to the Company. Carne also provides other fund governance and country registration services to the Company. The fees paid to Carne were €164,610 (approximately US\$180,521) for the period from 1 July 2016 to 31 December 2016 (1 July 2015 to 31 December 2015: €35,218 (approximately US\$38,856)).

13. Related Party Transactions (continued)

Additionally, Mark R. Shenkman is a Director and the President and majority shareholder of Shenkman Capital Management, Inc., which is a shareholder of Shenkman Finsbury Short Duration High Income Fund. The remaining Directors did not hold any shares in the Company during or as at the end of the financial period.

Connected Parties

Regulations 41 of the Central Bank UCITS Regulations "Restrictions on transactions with connected persons" requires that any transaction between a UCITS and a connected person is conducted at arm's length and must be in the best interest of the shareholders of the UCITS. The Directors are satisfied that:

(i) there are arrangements (evidenced by written procedures) in place to ensure that all transactions with connected persons are carried out on an arm's length's basis and are in the best interests of the shareholders; and (ii) all transactions with connected persons entered into during the financial period ended 31 December 2016 complied with the obligations that are prescribed by the Regulations 41(1) of the Central Bank UCITS Regulations.

14. Significant Events During the Financial Period

The Company appointed Kevin Molony as an Independent Director to the Board of Directors on 24 August 2016.

On 15 December 2016, an updated Prospectus for Shenkman Finsbury Global Convertible Bond Fund and Shenkman Finsbury Global High Yield Bond Fund was issued and noted by the Central Bank.

Shenkman Finsbury Global High Yield Bond Fund launched on 16 December 2016 following an inspecie transfer of assets from Shenkman Finsbury High Income Fund.

15. Subsequent Events

There were no significant events that occurred after the financial period end that would require disclosure in these financial statements.

16. Security Lending

There was no security lending during the financial period ended 31 December 2016 and 31 December 2015.

17. Cross Liability between Sub-Funds

Each Sub-Fund is responsible for paying its fees and expenses regardless of the level of its profitability. The Company is an umbrella fund with segregated liability between Sub-Funds and under Irish law the Company generally will not be liable as a whole to third parties and there generally will not be the potential for cross liability between Sub-Funds. There can be no assurance that, should an action be brought against the Company in the courts of another jurisdiction, the segregated nature of the Sub-Funds would be necessarily upheld. As at 31 December 2016, the Directors are not aware of any such existing cross-liability (30 June 2016: US\$ Nil).

18. Efficient Portfolio Management

Investment techniques and financial derivative instruments may be used for efficient portfolio management or investment purposes within the limits of the Company's Prospectus. For UCITS which have engaged in efficient portfolio management techniques, the use of techniques and instruments for efficient portfolio management purposes is subject to the conditions and the limits laid down by the Central Bank UCITS Regulations.

Notes to the financial statements (continued)

18. Efficient Portfolio Management (continued)

In accordance with the Central Bank UCITS Regulations, the revenues arising from repurchase agreements and stock lending transactions for the entire reporting period, together with the direct and indirect operational costs and fees incurred, should be disclosed in the financial statements of the UCITS.

During the financial period ended 31 December 2016 and the financial year ended 30 June 2016 the Sub-Funds did not enter into any repurchase agreements and stock lending transactions.

19. Securities Financing Transactions Regulation

During the reporting period the Sub-Funds have not invested in Securities Financing Transactions as defined in Regulation (EU) 2015/2365. Due to this fact, there is no obligation to disclose further information for such instruments.

20. Prior Period Comparatives

The prior period comparatives for the Statement of Financial Position are as at 30 June 2016. The prior period comparatives for the Statement of Comprehensive Income, the Statement of Changes in Net Assets Attributable to Holders of Redeemable Participating Shares, and the Statement of Cash Flows are for the period ended 31 December 2015.

21. Approval of Financial Statements

The financial statements were approved by the Board on 15 February 2017.
