What is this product?

This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

This sub-fund has no maturity date. However, the manufacturer may decide to close the sub-fund under certain circumstances.

The sub-fund's objective is to offer its shareholders long-term capital gains. This objective will be pursued by investing the assets of the sub-fund in fixed income instruments, as well as cash or similar instruments and without geographical limitation. At least 51% of the assets of the sub-fund will be invested in emerging economies without sector or currency restrictions.

The sub-fund aims to generate return from current income and capital appreciation by investing into fixed income securities that have been actively selected by the Investment Manager. The selection will predominantly (i.e. at least 90% of the bond portfolio) include instruments issued by governments, government agencies, supranational bodies and/or government guaranteed issues. The sub-fund is allowed, to a limited extent (i.e. not more than 10% of the bond portfolio) to invest in fixed income instruments issued by corrected entities or other folio) to invest in fixed income instruments issued by corporate entities or other private sector entities that do not benefit from an explicit government guarantee. The sub-fund has the ability to invest in fixed income securities that are issued in local emerging market currencies or fixed income securities that are issued in non-emerging market currencies, with no restriction. The sub-fund's neutral investment universe is a combination of a 30% hard currency EM bonds and 70% EM Local currency bonds. Maximum weight per issuing country is capped at 15% of the sub-fund's net assets.

The sub-fund is managed actively and will invest in securities based upon macro-economic analysis, specific issuer's analysis, political analysis, valuations and / or other considerations the investment manager deems appropriate. At least half of the bond portfolio will be invested in investment grade credit at the time of purchase of the relevant fixed income instruments. In the case where the bonds issues have no rating, the rating of the issuer itself will be used, if available

In an ancillary manner, up to 20% of its assets, the sub-fund may hold cash

The sub-fund may, subject to the limits defined by law, invest in financial derivative products, including, for example, futures, options, forward exchange contracts, credit default swaps or interest rate swaps in order to achieve the investment objectives and for risk hedging purposes.

What happens if ECONOPOLIS FUNDS is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Banque de Luxembourg. Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible ínvestment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario

How long should I hold it and can I take money out early?

Recommended holding period: 5 years
