What is this product?

Type

The Polar Capital Income Opportunities Fund (the "Fund") is an investment fund. The Fund is a sub-fund of Polar Capital Funds Plc, an open ended investment company, incorporated with limited liability in Ireland.

Term

This product does not have a maturity date.

Objectives

The objective of the Fund is to achieve income together with capital growth, by investing in financial sector companies.

Intended Retail Investor

This product is intended for all investors (including those with a basic level of investment knowledge) who are seeking a return on their investment and who can accept the risk of losing some or all of their original investment. The product should be considered a long-term investment, defined as five years or more.

This is an Undertaking for the Collective Investment in Transferable Securities (UCITS) product.

Investment Policy

The Fund invests worldwide in securities of listed financial companies and companies which provide support services to such financial sector companies. The Fund may also invest in companies which derive a substantial proportion of their profits from the financial sector. The Fund focuses on bonds and shares issued by financial-related companies. The Fund mainly invests in fixed-income securities (e.g., bonds), including convertibles (bonds which can be converted into companies' shares), debentures (an unsecured bond) and other bonds issued by financial-related companies. The Fund invests in bonds which pay a fixed or variable rate of interest. Up to a maximum of 25% may be invested in bonds which are unrated (bonds which have not been given a credit rating by a ratings agency). All other bonds will be either investment grade (higher quality) or high yield (lower quality, but which pay a higher rate of interest). The Fund may invest in financial derivatives (complex instruments based upon the value of underlying assets) for hedging, to reduce risk, to manage the Fund more efficiently, or to gain exposure to securities in a more efficient way. The Fund is actively managed and uses the STOXX EUROPE 600 Financials (Net Return) Index (GBP) benchmark for performance comparison purposes and to calculate the performance fee. The currency of the Fund is British Pounds and the currency of this share class is British Pounds.

There is no intention to pay dividends in respect of the Accumulation Share Classes.

Higher Risk

The risk indicator assumes that you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity of the PRIIPs manufacturer to pay you.

We have classified this product as 4 out of 7, which is a medium risk class.

If the product currency differs from your investment currency, the following applies: Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Due to effects of unusual market conditions, other risks could be triggered. Please see below for more detail.

Interest Rate Risk – interest rate movements affect the value of bond investments in the Fund. Typically, the value of a bond will fall if interest rates rise.

Credit Risk - there may be times where the issuer or guarantor of a convertible or fixed income security cannot meet its payment obligations or have their credit rating downgraded, resulting in losses for the Fund.

Emerging Markets Risk – this Fund invests in countries which may face more political, economic or structural challenges than developed countries. Investments in such countries may not be as well regulated, may be more difficult to buy and sell and have a higher potential for gains or losses.

Investment Risk – the Fund invests in company shares globally, and share prices can rise or fall due to a number of factors affecting global stock markets.

Derivative Risk – certain derivatives may result in gains or losses that are greater than the original amount invested. Derivatives also involve counterparty risk, which is the risk that a counterparty to the derivative contract cannot meet its contractual obligations.

Currency Risk – the Fund invests in assets denominated in currencies other than the Fund's base currency. Changes in exchange rates may have a negative impact on the Fund's investments.

Performance Scenarios

The figures shown include all the costs of the product itself, but may not include all the costs that you pay to your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the product over the last 10 years. Markets could develop very differently in the future.

The stress scenario shows what you might get back in extreme market circumstances.

The moderate scenario occurred for an investment between October 2013 and October 2018.

The favourable scenario occurred for an investment between September 2012 and September 2017.
