Objectives and Investment Policy

SEB TrendSystemRenten aims to increase the value of your investment over time by outperforming the benchmark. This actively managed fund focuses primarily on fixed income markets in EU member states in the monetary union. We compare the fund's return to Barclays Euro Treasury 1-10 Year Total Return Index Value Unhedged EUR, a fixed income index. The majority of the fund's holdings are constituents of the benchmark, but they differ in weight. The fund's investment strategy does not aim to restrict how much the fund's holdings deviate from its benchmark. Deviation, measured as tracking error, will likely be medium compared to other fixed income funds.

The main categories of financial instruments are bonds, including zero coupon bonds, from public sector issuers in the European Monetary Union, and other debt instruments as well as money market instruments with a minimum credit rating of BBB- on Standard & Poor's scale or the equivalent. 
