## Objectives and Investment Policy

- The aim is to provide capital growth and income on your investment over time.
- The Fund will invest at least 90% of its assets in fixed income securities, other instruments related to the Indian Rupee ("INR"), including up to 20% in cash and cash instruments.
- The Fund will invest in high and lower quality and unrated fixed income securities. These are issued by the Indian Government or Indian companies and companies which carry out most of their business in India.
- The Fund may be subject to a limit on its investments in India. Where this is the case the Fund may invest in non-INR denominated fixed income securities or derivatives.
- The Fund may invest up to 100% in securities issued or guaranteed by the Indian government or Indian government agencies.
- The Fund may invest up to 10% of its assets in contingent convertible securities (CoCos).
- The Fund may invest up to 10% of its assets in other open-ended funds, including other Funds of HSBC.
- The Fund may use derivatives to meet its investment objectives.
- The Fund may also use derivatives for hedging or efficient portfolio management purposes (such as to manage risks or costs or to generate additional capital or income).
- The reference currency of the Fund is USD. The reference currency of this share class is USD.
- The Fund is actively managed and is not constrained by a benchmark.
- Income is reinvested.
- You may sell your investment on most working days.
- Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.

### Why is this Fund in this specific category?

This Fund is classified in category 4 because its price or simulated data has shown medium fluctuations historically.

### Material risks not fully captured by the Risk and Reward Indicator:

- **CoCo Bond Risk** Contingent convertible securities (CoCo bonds) are comparatively untested, their income payments may be cancelled or suspended, and they are more vulnerable to losses than equities and can be highly volatile.
- **Counterparty Risk** The possibility that the counterparty to a transaction may be unwilling or unable to meet its obligations.
- **Credit Risk** A bond or money market security could lose value if the issuer's financial health deteriorates.
- **Default Risk** The issuers of certain bonds could become unwilling or unable to make payments on their bonds.
- **Derivatives Risk** Derivatives can behave unexpectedly. The pricing and volatility of many derivatives may diverge from strictly reflecting the pricing or volatility of their underlying reference(s), instrument or asset.

- **Liquidity Risk** Liquidity Risk is the risk that a Fund may encounter difficulties meeting its obligations in respect of financial liabilities that are settled by delivering cash or other financial assets, thereby compromising existing or remaining investors.
- **Operational Risk** Operational risks may subject the Fund to errors affecting transactions, valuation, accounting, and financial reporting, among other things.

## Charges

The charges you pay are used to pay the running costs of the Fund, including the marketing and distribution costs. These charges reduce the potential growth of the investment.

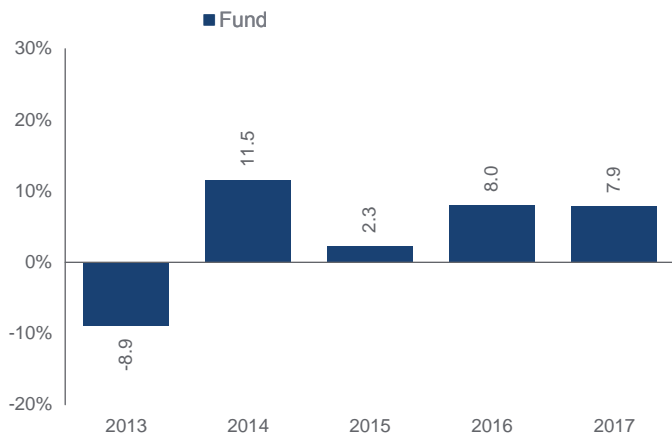
