

Manager Comment

In Political developments took centre Portfolio Date: 30/11/2024 stage in November. Donald Trump won the US presidential election by a surprisingly clear margin. As his party also won both chambers of Congress, the ability to push through his political agenda should become much easier. In the coming months, the focus will be on issues such as tariffs, trade wars, deglobalisation, deregulation, inflation and the resulting impact on the economy. Any measures could at least stabilise, if not boost, growth in the US. US equities are also likely to benefit from this in 2025. In Europe, however, the situation is different, particularly in France and Germany. There is no end to political squabbles. France is heading for fresh elections due to the budget dispute, while new elections have Fund Allocation already been scheduled in Germany. The poor economic situation in Europe is unlikely to change much for the time being and the prospect of structural and reforms thus possible improvements remains rather bleak. The European stock markets have so fai been unimpressed by this. As expected, it was mainly US companies that set the tone for the Q3 reporting season, although their results did not have a negative impact on the market.

The Moventum strategies had a strong month in November, especially the more equity-heavy strategies. The bond markets were characterised by high volatility, but we were able to counter this well with our more defensive approach. We are looking forward to the final month of December with confidence.
